Draft Annual Report for the year 2011-2012 of Karnataka P&T Pensioners' Association

The Executive Committee of the Association is pleased to place the draft Annual Report for the year 2011-12 before the Annual General Body Meeting to be held on 24th June 2012.

- 2. The office bearers elected in the year 2010 continued to function during the year under report except for the under mentioned changes:
 - (i) Sri K.Arumugham was co-opted by the Executive Committee as E.C.Member in place of Sri A.Malleswar, who resigned
 - (ii) Sri M.S.Krishnamurthy was co-opted by the Executive Committee as E.C.Member in place of Sri M.G.N. Murthy, who resigned.

Monthly meetings of the Executive Committee took place regularly on 2nd Saturdays.

3. Our own Building ""¦AZktkAgkj\\"\"PE\\" "Pensioners' Bhayan"

3.1 As we meet in the AGB, we are realisng one of our greatest dreams, i.e., becoming the proud possessors of our own building. After laying the foundation stone for the building on 19th September, 2010, by Justice Sri M.N. Venkatachalaiah, Retd. Chief Justice of Supreme Court we had planned opening of the building on Pensioners' Day on 17th December, 2011. There was some delay in getting the plan sanctioned and identifying a suitable contractor for construction. Some changes from the original plan of the structure had also to be made. While in the ground floor, we have a mini hall with 50seating capacity, an office-room and three guest rooms, the major change effected is in respect of the first floor. The proposed Auditorium in the first floor was changed into three guest rooms, drawing-cum-dining hall, a kitchen with a workarea and a balcony at the entrance. The change in the first floor was made, as we felt that the hall may not be having enough seating capacity for conducting our General Body Meetings and it may not generate any income. Also, until the area gets connected with sufficient public transport facility, there may not be enough demand for all the six quest rooms. We will, for the present, retain only the three guest rooms in the ground floor, the office room and also the mini hall for our use. The area is developing fast with four-lane road connectivity and is expected to get fully developed within a period of about two years. The guest rooms are proposed to be given at a very nominal rent to Central Government pensioners visiting Bangalore for short duration. With a view to strengthen pensioners' movement, the renting of guest rooms will be restricted to pensioners who are members of any Central Government Pensioners' Association from any part of the country.

- 3.1. In completing construction of our building, we would like to place on record the moral and material support from Sri G.Babu, President, Telecom Employees Co-operative Housing Society Ltd., with whose encouragement only we had gone ahead with construction. We would like also to thank Sri C.Murthy, the contractor of the Building for his role in ensuring good quality in executing the work.
- 3.2 We also would like to place on record the financial support given by members. Some of them were very liberal beyond our expectations. Children and relatives of some members have also donated for the building fund and some were very liberal. Some well-wishers have also donated for the building fund.
- 3.3. While the Telecom Employees Co-operative Society gave us the site at the original allotment rate, we got a substantial donation from the Ministry of Communications Employees Co-operative Housing Society Ltd. We got donations from some of the Credit Co-operative Societies in Postal and Telecom/BSNL, Serving Employees' Unions and Pensioners' Associations.
- 3.4. We thank all those who rendered material and moral support for realising our dream of owning a building.
- 3.5. Our achievement in this connection is unique since no other Pensioners' Association in the country has been able to construct a building of this type with the facilities mentioned above.
- 4. Revision of pension in BSNL and receipt of Revised Pension Payment Authorities

(RPPA)by members

- 4.1. The work in BSNL regarding revision of pension is almost complete
- 4.2. Almost all our members have received RPPA. A few who had not received RPPAs have reported the same to us in the proforma published in Pensioners' Champion. We have registered their cases in the CPENGRAMS in the Pensioners' Portal and we are periodically monitoring their progress.

5. Pending demands in connection with VI CPC

- 5.1. The Memorandum on pending demands of pensioners prescribed by Bharat Central Pensioners Confederation (BCPC) and National Coordination Committee of Pensioners Association (NCCP) (to which we are affiliated) to be presented to the Prime Minister was got signed during the last AGB meeting and was despatched to BCPC. The Memorandum was presented, after a mass rally in New Delhi on 25-11-2011 along with a Memorandum signed by serving employees to the Prime Minister by a delegation of representatives of Serving Employees' Unions and Pensioners' Associations. Action on the Memorandum is still pending. though assurances of favourable consideration during the meeting were extended.
- 5.2. The appeal of the Government in the High Court of Delhi against the favourable decision on 1-11-2011 of Principal Bench of CAT, New Delhi, regarding updating of revised pension under VI CPC is being heard, as we meet during the AGB. Proceedings are expected to be continued after the court vacation.
- 5.3. Action is being taken by Headquarters of AICCPA, New Delhi, for filing the case in connection with JAG-PB3/PB4 Muddle.

6. Other Legal cases taken up

6.1. Case of P&T Pensioners denied CGHS facility: The SLP filed by the Government against the favourable decision of High Courts is pending disposal in Supreme Court. CGHS benefits, however, has been extended to the affected P&T pensioners, as the High Court of Karnataka, has upheld CATs Orders and the Supreme Court has not granted stay on its implementation.

7. CGHS Matters

- 7.1. Wellness Centre No. 1 and Polyclinic have been got shifted to a better accommodation near the bus terminus in Shivajinagar.
- 7.2 . Advisory Committee Meetings at Wellness Centre-levels in almost all Wellness Centres are being held regularly. Senior Citizens, 80+age, are getting preference in consultation. A joint meeting of all pensioner-nominees of Advisory Committees of Wellness Centres with the Additional Director was held on 28-9-2011. Representatives of CCCGPA met the "Sub Committee of Department-related Parliament Standing Committee of MoH & FW on the Functioning of CGHS" and presented a memorandum on problems connected with CGHS on 5-11-2011. On shortage of doctors, liberalizing norms in filling up short term vacancies of doctors, revision of SIU report and opening of another Polyclinic, we have written a detailed letter on 6th May 2012 to the Addl. Secretary & DG, CGHS. This letter has been published elsewhere in this issue of the journal.

8. Our role in connection with "Pensioners' Portal"

We have filed grievances of some pensioners/family pensioners making use of the CPENGRAMS, and are monitoring their disposal and informing the concerned pensioners/family pensioners. A meeting was arranged on 17th March 2012 by our Association for an "Awareness-Cum-Training Programme on Webenabled Pension Grievance Redress and Monitoring System (CPENGRAMS) hosted by the DoP & PW and inaugurated by Sri Ramesh C.Misra, Secretary, DoP & PW in the presence of the Director and other Officers of the DoP & PW and NIC. This is the second such meeting after the one conducted at Chandigarh and according to the DoP & PW, similar meetings are proposed to be conducted by DoP & PW for the benefit of pensioners/family pensioners in other parts of the country. Selected photos of the meetings at Chandigarh and Bangalore can be seen under the heading "Photo Gallery" in Pensioners' Portal. Our demand for increase in Grant-in-Aid, for provision of office rent and allowance for data entry operator and also limited discretion in reappropriating allotment under different heads has been conceded. The amount of Grant-in-Aid has been increased to Rs. 75,000/- with effect from the current financial year.

9. Other activities in brief:

- Sri S.M.Vittal Rao, our Treasurer, represented our Association as a delegate in the AGB Meeting of AIFPA held at Chennai on 29th/30th July 2011.
- ii) As usual, we held a charitable function under the initiative of our Treasurer, Sri S.M.Vittal Rao, at the Government Primary School, 4th Phase, Yelahanka Satellite Town, on 6th February, 2012 by distributing cakes and fruits among students.
- iii) Our revised updated up to November 2011, 7th edition of "Compendium on Pension CGHS and Medical Facilities for Central Government and BSNL Pensioners" was released on 28th December 2011 by Dr. V.C.Shanmuganandan, Addl. Director, CGHS. Dr. Shanmuganandan was very popular among CGHS beneficiaries and in recognition of his services; our Association gave a "Fare Well" to him on that day on the eve of his retirement a first of its kind.

10. Pensioners' Champion

Many members outside Karnataka have become subscribers to our monthly journal finding its utility. Some from places like New Delhi, Calcutta and from different States have also become members of our Association. For getting copy of the journal by pensioners/family pensioners resident in Karnataka, we insist on becoming a member of our Association or of any affiliate Associations of CCCGPA, Karnataka. Subscription for the journal had to be increased from January 2012 onwards owing to increase in cost of printing during the last four years. Renewal of subscription of almost all members, except in respect of few, is due from July 2012. Those desirous of renewing their subscription may pay the amount while attending the AGB meeting.

11. Membership and Finance

As can be noticed from our monthly journal, there has been steady increase in our membership. We were sanctioned an amount of

Rs. 27,356/- as Grant-in-Aid for 2011-12 in connection with Pensioners' Portal. The difference in amount had to be met from the General Accounts of the Association.

12. Our thanks

- i) We thank the Chief Postmaster General and her staff including the Director of Postal Accounts in attending to the grievances/problems of pensioners/family pensioners
- ii) The Controller of Communication Accounts and his staff for drawing promptly the arrears due to BSNL pensioners/family pensioners on account of revision of pension and issuing Revised Pension Payment Authorities to almost all DoT and BSNL pensioners/family pensioners.
- iii) Sri A.Rajgopal, Partner, GSMR Associates for auditing our accounts promptly
- iv) Sri A.R.Holla, Advocate, for helping our Association in legal matters
- vi) Smt. Rama and Sri Achyuta of Omkar-Hi-Prints, our printers for the co-operation extended to us in making available to us our monthly journal for posting in the scheduled dates and also for the excellence in printing the 7th edition of "Compendium on Pension, CGHS and Medical Facilities for Central Govt. and BSNL Pensioners", about which we got lot of appreciation.
- vii) and lastly, all our members for the help and co-operation extended in completing the gigantic task of constructing our building. As pensioners and family pensioners, we enjoyed/are enjoying lot of benefits on account of the good work done by those in the pensioners' movement prior to our joining the movement and we have the satisfaction of having paid back "a part of this debt" in the form a permanent abode for the Association to function more effectively.

Necessity for review of the outmoded SIU (Staff Inspection Unit) formula

(ii) Acute shortage of doctors in CGHS Wellness Centres in Bangalore and (iii) Necessity for opening a second Polyclinic in Bangalore

(Copy of letter No. CCCGPA/CGHS/SIU/1 dated 4th May, 2012 from Coordination Committee of Central Govt. Pensioners' Associations, Karnataka to Sri L.C.Goyal, Additional Secretary & Director General (CGHS), Ministry of Health Family Welfare (Gol). New Delhi)

We wish to submit the following in connection with each of subjects mentioned below for your favourable consideration and appropriate remedial action:-

2. (I) Shortage of Doctors in CGHS -Necessity for a review of the outmoded SIU formula and (II) Acute shortage of doctors in CGHS Wellness Centres in Bangalore: A detailed letter was addressed to you under our case mark No. CCCGPA/CGHS/SIU dated 15th May, 2011*. No reply has so far been received though the necessity for the same has been wellexplained in the letter with facts and figures. The situation in Bangalore after we wrote letter in May 2011 has got worsened for the beneficiaries. In almost all Wellness Centres, though the number of doctors justified is three as per the existing formula and three doctors have been posted, the actual strength in majority of the Wellness Centres on most of the days is two as a result of one of the doctors either being on leave or on other duties. In some Wellness Centres, for the same reason a single doctor, on some occasions, had to manage the establishment making the waiting period for consultation for about two hours and sometimes, some beneficiaries had to return disappointed without getting the facility of consultation. As an immediate remedial measure, the existing terms and conditions for engagement of retired doctors of CGHS for meeting shortage of doctors on contract basis, needs liberalisation taking into account the ground realities. Action on our appeal for review of SIU formula for making it more liberal needs to be considered urgently and we request you to kindly initiate the same.

- 3. (iii) Necessity for opening a second Polyclinic in Bangalore: This issue is one of the long-pending demands of CGHS beneficiaries in Bangalore. On account of the heavy rush in the Polyclinic for consultation with specialists like Medical, Eye, ENT, the number of patients entertained for consultations is restricted to 30 per day for each of these specialists and tokens for consultation are issued at the commencement of working hours of the Polyclinic. virtually a scramble for getting the tokens in the morning hours in the premises of the Polyclinic with the beneficiaries - almost all advanced in age and infirm-- standing on the steps of staircase leading to the third floor (wherein the Polyclinic is located) as early as one hour before the scheduled opening of the Polyclinic. These tokens are exhausted within an hour of opening the Polyclinic and some beneficiaries visiting later have to return without getting the facility of consultation. A second Polyclinic in the Southern part of Bangalore, in addition to the existing one located in the Northern part, has to be opened as a solution to this problem.
- 4. We had brought the above mentioned issues to the notice of the "Sub-Committee of the Department-Related Parliamentary Standing Committee of Health & Family Welfare on the functioning of CGHS" when they visited Bangalore on 5th November 2011.
- 5. We request you to kindly take necessary action at your level on all the three issues cited above to make the CGHS more beneficiary-friendly.

Legal Matter

1.Cases pertaining to medical reimbursement claims of pensioners residing in non-CGHS areas

The Hon'ble Supreme Court of India has, in its order dated 3-4-2012, **dismissed** the following 34 SLPs (C) pertaining to the above subject making the under mentioned

observation :-

"After having heard Mr. P.P.Malhotra, learned Additional Solicitor General, at length and after perusal of the impugned order, in the facts and circumstances of the cases, we are not inclined to interfere against the impugned orders passed by the High Court. The Special Leave Petitions are hereby dismissed."

SLPs dismissed: 15597 & 22812 of 2004. 3714, 4193, 4194, 5921, 8539, 9309, 19659, 10660,10661, 17109, 25685 & 25686 of 2005.

10961, 12803,13075,14253 & 20515 of 2006. 1063 & 8894 of 2007. 2640,18267,20513 & 27589 of 2008. 7551, 24110 & 35459 of 2009.

2144, 24667 & 35429 of 2010. 6092, 9073 & 23324 of 2011.

Three Writ petitions filed in the High Court of Karnataka by S/Sri D.R. Joshi, P. Narayana Madivala and Babu Nairy on the above subject, it is hoped, will be disposed of early in view of dismissal of the SLPs by the Apex Court. We are in touch with our Advocate, Sri A.R. Holla.

2. Writ Petition (C) No.1535/2012 filed by the Government of India challenging the decision of CAT (Full Bench) Principal Bench, New Delhi in OA No. 655/2010 regarding extension of "Modified Parity" in pension to all Pre-2006 retirees:

The case was directly taken up for arguments by both the parties. Arguments on behalf of the Government (Petitioner) were advanced on 4-5-2012 and arguments on behalf of Respondents (SAG (S-29) Pensioners' Association) was commenced on 7-5-2012. This was continued on 21-5-2012 and on that day it was decided to have further hearing after court vacation.

3. Filing of Application in CAT Principal Bench, New Delhi regarding JAG PB3/PB4 muddle:

The final draft of the application has been got ready. It will be filed as soon as the Tribunal reopens after the vacation this month.

4. Other cases before CAT Bangalore:

- i) Case of Sri Sadashivaiah, Retired Technical Asst., Central Cattle Breeding Farm, Avadi, Chennai (Ministry of Agriculture,) demanding Grade Pay of Rs. 4600/- (OA-449/2010) has since been decided in his favour. Not only this- A sum of Rs. 5000/- has been awarded towards "Cost' to him!
- ii) Case of Sri M. Venkatesan, Retd. Scientific Officer, NFC, Hyderabad demanding counting of his spell of previous service in Rajasthan Atomic Power Project and spell of leave in continuation (about 4 years) as service qualifying for pension, so that he may get full pension. The case filed in CAT Bangalore has been admitted (OA-51/2012) and the next date for hearing is 4-6-2012.
