7th CPC Pre 2016 Pensioners to get parity in pension based on 5th CPC recommendations instead of computation of their pension in terms of Option-1 recommended by 7th CPC in para 10.1.67 of its report?

The 7th Central Pay Commission vide para 10.1.67 of its report had recommended that "(i) All the Civilian personnel including CAPF who retired prior to 01.01.2016 (expected date of implementation of the Seventh CPC recommendations) shall first be fixed in the Pay Matrix being recommended by this Commission, on the basis of the Pay Band and Grade Pay at which they retired, at the minimum of the corresponding level in the matrix. This amount shall be raised, to arrive at the notional pay of the retiree, by adding the number of increments he / she had earned in that level while in service, at the rate of three percent. Fifty percent of the total amount so arrived at shall be the revised pension."

Govt. of India vide its resolution dated 4-8-2016(published in *Pensioners' Champion* Aug-2016 issue) while accepting the recommendation, had stated that "Both the

options recommended by the 7th Central Pay Commission as regards pension revision be accepted subject to feasibility of the implementation. Revision of pension using the second option based on fitment factor of 2.57 be implemented immediately. The first option may be made applicable if its implementation is found feasible after examination by the Committe comprising Secretary (Pension) as Chairman and Member (Staff). Railway Board, Member (Staff), Department of Posts, Additional Secretary & Financial Adviser, Ministry of Home Affairs and Controller General of Accounts as Members"

The Committee constituted to examine the feasibility of implementation of option-1, headed by the Secretary, Department of Pension & Pensioners' Welfare as its Chairman, held a meeting with Pensioners' Associations who are Members of SCOVA on

5-10-2016 to ascertain the views of the Associations. The Secretary, Karnataka P&T Pensioners' Association, Bengaluru, represented the Association in the meeting. The Additional Secretary (Pension), through a power point presentation, explained the position regarding the requirement of records and the factors which may affect the feasibility of implementation of option-1 and for arriving at the notional pay in Seventh CPC Pay Matrix by adding the number of increments earned by the Pensioner while in service in the scale of pay from which he had retired, as recommended by the 7th CPC. The Addl. Secretary also mentioned about the anomalies that are likely to arise. The Associations were informed that the reports received from several Departments have revealed that service records are not available in around 18.3% cases, which approximately works out to about 7 lakh Pensioners.

The Addl. Secretary stated that the Committee after a thorough examination has found that it would be extremely difficult to extract the information for determining the exact number of the increments earned for revision of pension under the first option in the absence of service records. Suggesting a new formula, the Addl Secretary said that the Committee has found that an alternative method of arriving at notional pay in Seventh CPC by application of rules for revision of pay of serving employees under each of the successive pay Commissions and computation of pension at 50% of the notional pay so arrived at is beneficial to all Pensioners and sought the views of the Pensioners' Associations on the new formula proposed by the Committee.

Sri K.B.Krishna Rao, Secretary, KP&TPA, said that the Association had suggested a different formula for implementation of option-1 in the Memorandum submitted by it to the Empowered Committee and the Department of Pension (published in *Pensioners' Champion* January 2016 issue) as

per which option -1 could be implemented even in the absence of service records.

The Suggestion: Quote

"The number of increments to be added to the minimum pay in the pay level of the Pay Matrix (to arrive at the notional pay of the retiree) shall be determined by the number of stages commencing from the first stage to the stage at which the last pay was drawn by the retiree in the pay scale from which he/she had retired.

This suggested method of determination of number of increments will simplify the process of counting the number of increments, since the particulars required are only (1) the pay scale from which the pensioner had retired and (2) the last pay drawn, which can be ascertained from the PPOs and there will not be any need to consult the service records. After determining the number of stages of the retiring pay scale as suggested, the notional pay for calculation of revised pension may be determined by counting equal number of stages in the pay matrix under 7th CPC .The process of equating the number of stages in the retiring pay scale with the Cells in the new Pay Matrix will eliminate the need to calculate the number of increments at the rate of 3 % as suggested by the 7th CPC in the case of pre-2006 retirees who drew their pay in the standard pay scales. In respect of post 2006 retirees, the numbers of increments may be counted from the entry pay for each Grade Pay indicated in Section -II of CCS (Revised Pay) Rules, 2008 .The number of increments from the entry pay to the last pay drawn can be arrived at by calculating the amount of increase at the rate of 3% of the Basic Pay (pay in Pay Band + Grade Pay).

Continuing with his submissions, Secretary, KP&TPA, stated that the suggestion made by the Association on implementation of option-1, if accepted, would be more beneficial and can be implemented even in the absence of service records. The Chairman of the Committee, responding to the request of KP&TPA, stated that it is beyond the recommendations of 7th CPC and may result in huge financial implications.

However, all other Pensioners' Associations attending the meeting agreed with the new formula suggested by the Department of pension on revision of pension of pre -2016 Pensioners.

We have given some illustrations in this journal on revision of pension as per the new formula suggested by the Department of Pension in place of option-1 recommended by the 7th CPC .It is found that the amount of

pension computed in accordance with the new formula proposed by the Department of Pension and Pensioners' Welfare is more than the amount of pension calculated by applying the multiplication factor of 2.57 as per Option- 2 recommended by 7th CPC and therefore is beneficial to pre -2016 Pensioners, though it may not be as beneficial as computation of pension under option-1 in some cases. However, we urge the Committee headed by the Secretary, DoP&PW to allow the new formula suggested by the Committee as 3rd option in addition to the two options recommended by 7th CPC and allow pre-2016 Pensioners to opt for a formula whichever is beneficial to them.

Brisk walking, Cycling may cut diabetes risk

People who carry out an hour of moderate to vigorous exercise every day can reduce their risk of getting type-2 diabetes by 40%, a new study has claimed.

The study also showed that brisk walking or cycling for 150 minutes a week can reduce a person's risk of developing type 2 diabetes up to 26%.

Researchers from the University College, London (UCL), and Cambridge University in the U K found that any amount of physical activity can reduce the risk of developing the disease.

The UK department of Health recommends 150 minutes of moderate to vigorous exercise a week, which includes brisk walking, gentle cycling or sports such as doubles tennis.

According to the Health survey for England (2012), as many as a third of adults are not meeting this target.

The Study demonstrated that while any amount of physical activity is good for you, the benefits of exercise are greater for people who exceed this recommended level.

The study analysed data from 23 studies carried out in the US, Asia, Australia & Europe.

By combining observations from these studies, the Researchers were able to separate out the effect of leisure time physical activity form other behavioural factors, and obtain better estimates of the effects of different physical activity levels.
