

2. Activities

2.1. Construction of Pensioners' Bhavan Annexe

As unanimously decided in the AGB held on 4-6-2016 to construct an annexe to the Pensioners' Bhavan in the site measuring 1335 Sq ft, in front of the existing building, allotted to the Association by the Telecom Employees' Cooperative Housing Society, by raising donations from members, subscribers to the association's journal and well wishers. the association commenced the process of construction in right earnest and foundation stone of the new building was laid Sri G Babu, President of Telecom Employees Cooperative Housing Society in the AGB held on 16-7-2017 in the august presence of Dr Charles Lobo, Chief Postmaster General, Karnataka. The construction commenced in December 2017, and civil works of the ground and first floors are completed. The opening of the New Annexe is also being held today. The Annexe is being declared open jointly by Shri B.Sadashiva Rao, IPS(Retd) the founder President and Shri.N.Bhaskaran, Veteran P&T Trade Union leader & the founder Secretary.

In order to construct the building, the Association has been making appeals for donation. The Executive Committee is proud to announce that, till March 2018, we have been able to collect about 42 lakh rupees from more than 700 members. 4 members have donated Rs. one lakh and more; 7 members Rs.50000; 40 members Rs.25000 and 111 members Rs.10000 and more. It is proposed to display the names of donors, contributing Rs.25000/- and more, on granite stone. The names of those, who contribute Rs.10000/- and more, will appear on a board. The names

of all the donors are published in *Pensioners' Champion* every month. The list of donations received up to 20.4.2018, is also uploaded to the association's website kptpa.org. Our dream of constructing a big meeting hall in the 2nd floor for conducting AGB may not come true immediately due to paucity of funds. However, provision for a lift has been made in the building and may be installed in future as and when the association is in a position to meet the expenditure. The Executive Committee expresses its gratitude to all the donors for their generosity and appeals to those who are yet to respond to donate liberally.

2.2. Publication of a supplement to the 8th edition of Compendium on pension

In the last Annual General Body Meeting held on 17.6.2017 at NGO Hall, Cubbon Park, Bengaluru. Dr. Charles Lobo, Chief Postmaster General, Karnataka Circle, the Chief Guest, released the Supplement to Compendium brought out by the Association. The contents included gazette notification of VII CPC report, related govt orders, pay matrix with examples on pension revision and notional pay fitment tables.

2.3. AGB 2017

A record number of members and well wishers of the association, the highest number so far, including several members from outside of the state, attended the AGB. Foundation stone of the annexe was unveiled, cash prize of Rs.1000/- each was presented to 10 meritorious students of the Government Higher Primary School, Yelahanka, Bengaluru. 48 members, who had attained 75 years and above, were honoured. Sri A N Balaram, President Coffee Board Pensioners' Association was the guest of honour. Representatives of other Pensioners' Associations were also honoured. The minutes of the AGB with photos were published in June 2017 issue of Pensioners' Champion.

2.4. Seventh Central Pay Commission

2.4.1. The 7th CPC recommendations on

revision of pension of Pre-2016 pensioners vide options 1 & 2 were implemented in 2 stages. The 2nd option regarding revision of pension by multiplication of 6th CPC pension by a factor of 2.57 was implemented in August 2016. The first option, under which the notional pay for computation of pension had to be arrived at after adding the number of increments earned in the level from which the pensioner had retired, was not accepted by the government, citing reasons of non availability of service records of about 18 % of the retirees. Acting on the report submitted by the Committee constituted to examine the feasibility of implementation of option -I recommended by the 7th CPC, Department of Pension & PW Vide its OM dated 12.5.2017, issued an order modifying option -I in accordance with which, revised pension has to be computed at 50% of the notional pay that the pensioner would have drawn under 7th CPC, corresponding to the pay last drawn in the pay scale from which retired. The full text of the OM was published in May 2017 issue of Pensioners' Champion. The Association also published a 'Ready Reckoner' in this connection. The orders have been implemented in respect of postal pensioners to a great extent and fully in respect of DoT pensioners in Karnataka Circle.

The progress in revision of pension in respect of pensioners retired from other Central departments is abysmally slow especially in respect of pensioners of Railways and Defence civilians. Added to the woes of pensioners is the inordinate delay in payment of revised pension and arrears thereon by the pension disbursing banks, SBI topping the list.

2.4.2 Statutory / Autonomous bodies

We wish to note with deep regret and anguish that the benefits of 7th CPC have not yet been extended to the pensioners of Autonomous/Statutory Bodies under the Central Government. CCCGPA wrote to the Ministry of Commerce and Industries, urging implementation of 7th CPC benefits to

Autonomous/Statutory Body pensioners. Struggles by these pensioners have resulted in implementation of 7th CPC in respect of some Autonomous Bodies only. For the Pensioners of Autonomous Bodies under Commerce Ministry, viz. Coffee Board, Tea Board, Rubber Board Spices Board and MPEDA, the benefits are ordered to be given effect from 1.1.2018 instead of from 1.1.2016, forcing the pensioners to continue with their struggle. KP&TPA expresses its solidarity with the Pensioners Associations of Autonomous bodies in their continued struggle.

2.5. **BSNL**

In the memorandum submitted to the 7th CPC in our meeting with the pay commission in Bangalore, we had demanded that BSNL pensioners should be treated as central pensioners and all the benefits under 7th CPC should be extended to them on a par with other central civil pensioners. Though the Chairman remarked that 'there is a Prima facie', finally, in its report, the Pay Commission did not even make mention of the demand and BSNL pensioners have not got the benefits of pension revision, which is due to them at least from 1-1-2017.

BSNL Pensioners associations, especially AIBSNLPWA, Chennai has been pursuing the issue with DoT and the representatives of the association have met the Secretary DoT and other officers concerned and have impressed upon them about the need to delink the issue of revision of pension from revision of pay scales. It is understood that the demand for pension revision with VII CPC fitment benefit is being referred to Department of Pension and Pensioners Welfare by the DoT.

Two major demands of BSNL pensioners (1) merger of 78.2 % of IDA with pension from 10-6-2013 on par with BSNL employees and(2) rescinding of the condition that the annual pension liability of the government shall not exceed 60 % of the annual receipts

to government, were settled in the previous year. But another demand regarding the anomaly in fixation of pension of BSNL pensioners retired between 1-10-2000 and 31-7-2001 is still pending. Applications filed by some BSNL pensioners were allowed by CAT.DOT has filed a writ petition in Delhi High Court against the order of Hon'ble CAT and the case is pending.

2.6. Standing Committee of Voluntary Agencies (SCOVA)

The Association completed its 2nd consecutive term of two years each in the year 2017 and, therefore, is not re-nominated to the SCOVA in the Rotating Group for 2018-20. However, we sent items for inclusion in the agenda for discussion in the 30th meeting of SCOVA held 23.3.2018. One item suggested by us was included in the agenda. The text of the letter was published in the February 2018 issue of *Pensioners' Champion*.

3. Charitable works

3.1 Encouragement to Students

Like every year, the Association arranged a function in Government Higher Primary School, Yelahana, Bengaluru on 24.2.2018. Fruits, exercise books and pencils were distributed among the students. A report with photos appeared in the March 2018 issue of *Pensioners' Champion*. We thank Shri S.M.Vittal Rao, Internal Auditor, for donating a sum of Rs.25300 to meet the expenditure in connection with the said function. In the last AGB held on 17.6.2017, cash award of Rs.1000 each was given to 10 meritorious students of the same school.

3.2. Providing meal to cancer patients

Free lunch was served to the cancer patients at Kidwai Memorial Institute of Oncology, Bengaluru on 17-12-2017 from the donation made by the Association to the Institute.

4. Other activities

4.1. Executive Committee Meetings

- i. The Executive Committee of the Association met on 2nd Saturday of every month during the year in Pensioners' Bhavan, the Association's building in Telecom Layout. Agenda was fixed, items were discussed and minutes recorded.
- ii. To supervise the construction of the annexe to the Pensioners' Bhavan, a Building Sub Committee was formed consisting of 13 members. The members visited the site frequently to inspect the construction work. The photos of the construction at various stages were printed in *Pensioners' Champion* and circulated in WhatsApp group.

4.2. Pensioners' Day

'Pensioners Day' was observed on 17.12.2017 jointly by our Association with the Coordination Committee of Central Government Pensioners' Associations, Karnataka at Udayabhanau Kala Sangha, Kempegowda Nagar, Bengaluru 560019. Shri Y.S.Gundu Rao, the well-known humourist, was the Chief Guest. In this connection, Pensioners' Champion, November 2017 issue published an article on 'Pensioners' Day' in Kannada, (a translation of the article in English by K B Krishna Rao, Secretary KP&TPA) by Shri S.Radhakrishna, General Secretary, CCCGPA. Representatives of Nightingales Medical Trust, an NGO and HDFC Life New Zeal, also addressed the gathering. Reports on observance of Pensioners' Day by various other affiliated associations were also published in December 2017 and January 2018 issues of Pensioners' Champion.

4.3. Swach Bharath Abhiyan

As a part of the "Swach Bharath Abhiyan", the flagship programme of the Government of India, 'Swach Bharath' pledge was taken in the AGB held on 17.6.2017.

5. Pensioners' Welfare Activities

5.1. We received a number of grievances from our members regarding delay in revision of

their pension under 7th CPC. They were taken up with the concerned authorities and settled to the satisfaction of the pensioners. Family pensioners were also assisted in settling the pension cases. We are happy to note that members have appreciated our efforts by writing to us and the same is acknowledged in *Pensioners' Champion* occasionally.

- 5.2. Implementation of DoPPW OM dated 12-5-2017: The Association was in constant touch with Director of Accounts (Postal) and Controller of Communication Accounts, DoT, and has been giving the latest position of issue of revised PPOs in Pensioners' Champion. The Secretary, Joint Secretary, along with Shri N.Bhaskaran, Permanent Advisor, met Dr Charles Lobo, CPMG, Karnataka Circle on 5.1.2018 to discuss the delay in issue of revised PPOs as per OM dated 12.5.2017. CPMG responded positively and instructed DA (P) to expedite the matter. Special arrangements for issue of RPPOs were made by DA(P), as a result of which, except for a hundred and odd cases pending for various reasons, all pensioners have received RPPOs and arrears. Efforts of DA (P) in this regard are appreciated.
- 5.3. The Secretary along with the representatives of BSNL Pensioners' Association met CGMT and CCA, Karnataka Circle to urge them to expedite issue of revised PPOs in respect of DoT pensioners in accordance with OM dated 12-5-2017. We are pleased to state that RPPOs were issued to all 4200 DoT pensioners by December 2017. Efforts of CCA in this regard are highly appreciated.
- 5.4. Hundreds of members sought the assistance of the association in computation of their revised pension in terms of OM dated 12-5-2017. Work sheets with details of fixation of revised pension were made available to such members.
- 5.5. Various orders regarding implementation of 7th CPC benefits were downloaded from

the website of Pension department and published in *Pensioners' Champion* from time to time under the head '7th CPC. A simple formula for calculation of arrears of pension was given in February and March 2018 issue of *Pensioners' Champion*, which helped the pensioners in knowing the amount of arrears due to them.

5.6. CCCGPA, to which KP&TPA is affiliated, arranged a talk on 17-10-2017 on the subject "The role of Senior Citizens and Pensioners in the development of healthy society in a democratic setup" by Justice Shri N.Santosh Hegde, retired Supreme Court Judge and former Lokayukta, Karnataka. The full report on the same appeared in October 2017 issue of *Pensioners' Champion*.

5.7. The Association is affiliated to Bharath Pensioners Samaj, New Delhi, All India Federation of Pensioners Associations, Chennai and Co-ordination Committee of Central Government Pensioners' Associations, Karnataka. CCCGPA held its AGB on 2.7.2017. Shri K.B.Krishna Rao, Secretary, KP&TPA is also the Chairman, CCCGPA. EC members of the Association attended the meeting. AIFPA, Chennai held its Annual General Body Meeting at Chennai on 21.7.2017. Shri S.M.Vittal Rao, Internal Auditor, represented the Association. Bharath Pensioners Samaj held its AGB On 27.11.2017 at Ludhiana. Shri V.Gopal, Joint Secretary represented the Association.

5.8. Important orders regarding pension **5.8.1** Restoration of full pension of PSU absorbees: The Hon'ble Supreme Court in the Review Petitions No.465/2017 and 472/2017, allowed restoration of full pension after expiry of commutation period of 15 years to all employees, who, after absorption in PSU/Autonomous Bodies, had opted for 100% lumpsum amount in lieu of pension. The Department of Pension &PW in its order dated 23.6.2017, had stated that "all such absorbee petitioners may be allowed restoration of full pension". The Association, in its email dated 30.6.2017

to the Director (pension policy), DoP&PW sought a clarification and, as a result, the order was modified as "all such abosrbee pensioners" in July 2017 thereby extending the benefit of restoration of full pension to all PSU Absorbees. Extract of the corrigendum issued by DoP&PW was published in July 2017 issue of *Pensioners' Champion*.

5.8.2. The rate of Income tax for Financial Year 2018-19 (Assessment year 2019-20) as per the Budget of 2018 was published in March 2018 issue *Pensioners' Champion*.

6. CGHS matters

6.1. CCCGPA, Karnataka called for volunteers to work as "Pensioners Representatives" in the CGHS Advisory Committee in Wellness Centres and in Polyclinic for 2 year term 2017-2018 in December 2016. In the new panel, 7 members of KP&TPA were nominated as 'Pensioners' Nominees'.

6.2. Conceding a two decade old demand of P&T Pensioners, MoH&FW issued an order in July 2017, extending CGHS facility to P&T Pensioners, who were not CGHS beneficiaries while in service. Orders to this effect were published in July issue of *Pensioners' Champion*.

6.3. Fixed Medical Allowance was enhanced from the existing Rs.500 to Rs.1000 per month with effect from 1.7.2017. The said order was published in July 2017 issue of *Pensioners' Champion.*.

6.4. The Directorate of CGHS has issued the following guidelines for special provisions to CGHS beneficiaries aged 80 years and above. (A) Consultation at WCs without standing in queue; b) Doctors shall enquire by phone about their wellbeing; (c) Settlement of medical claim on priority out of turn and (d) Follow up treatment from the same specialist in non-empanelled hospital as a special case.

6.5. It is heartening to note that CGHS, during the year, introduced several beneficiary friendly measures, a few of which are given below.

- 6.5.1. CGHS beneficiaries are allowed to undergo treatment at empanelled private hospitals for specific treatment procedure, advised by Govt/CGHS Specialist without any other referral/permission letter from the WC. 6.5.2. All CGHS beneficiaries are permitted for seeking OPD consultation from specialists at private hospitals after being referred to by CGHS WC. The medicines prescribed by specialist shall be supplied by CGHS.
- 6.6. A meeting between the Additional Director, CGHS along with CMOs, and the representatives of CCCGPA was held on 22.1.2018. It was attended by the members of CGHS Advisory Committee. The report on the meeting appeared in March 2018 issue of *Pensioners' Champion*.
- 6.7. CGHS Wellness Centre No.3, Basavanagudi was shifted to a new location in Banashankari III Stage, Bengauru 560085 on 15 May 2017.
- 6.8. Denial of CGHS facility to pensioners of Autonomous bodies is continued. Unfortunately, no solution is in sight yet. KP&TPA reiterates its whole hearted support to Pensioners' Associations of these bodies in their struggle to achieve this demand.

7. Legal Matters:

- 7.1. Some members of KP&TPA challenged the MACP scheme in CAT, Bengaluru and won the case in April 2017. Department of Posts has filed a review petition.
- 7.2. Hon'ble High Court of Kerala, quashing the CAT order, has ruled that Postal pensioners retired before 1.4.1985 are not eligible for concessional telephone facility.

8. Our role in connection with Pensioners' Portal

K P&T PA is one of the pensioners' associations recognized by the Department of Pension & Pensioners' Welfare under the National e-Governance Plan (NeGP)-'Pensioners' Portal'. Under this plan, the Association has been receiving an annual grant-

in-aid of Rs.75,000/-.DoP&PW has made it mandatory to book the expenditure under 'Public Financial Management System-Central Sector Scheme (PFMS) - EAT module' from 1.4.2017 onwards. The Association has done it successfully, thanks to the help rendered by the concerned authorities in Bengaluru.

9. Our relationship with Department of Pension and Pensioners Welfare

As always, we have managed to maintain a very cordial relationship with DoP&PW. All orders on Pension matters, issued by the Department, are downloaded from the website at once and published in the journal *Pensioners' Champion* for information of our members. All necessary reports are submitted promptly to the Department.

10. Our Website

The Association has its own website www.kptpa.org. It has been maintained for the last 6 years now. The journal *Pensioners' Champion* and other important orders are being uploaded every month. The list of donors to the building fund is also uploaded recently. We request the members to visit the site regularly and suggest improvements. We request our members to join 'kptpa' WhatsApp group by contacting the Secretary.

11. Our Publications

- 11.1. 'Compendium on Pension, CGHS and medical facilities for Central Government and BSNL Pensioners', a publication of the Association, is a ready reckoner on pension matters and is in its eighth edition. Department of Posts and a few other Departments are giving a copy of this to their employees as a gift on the eve of their retirement. A supplement to the compendium with 7th PC recommendations was brought out in June 2017. The 9th edition of the Compendium is under preparation and, hopefully, will be brought out this year.
- 11.2. The Association's monthly journal Pensioners' *Champion* is also very popular. Matters of interest to pensioners find a place

in the journal, like report on SCOVA meetings, Govt orders, CGHS, BSNL matters, report on functions, health tips etc. Recently a column 'Our Readers Write' was introduced. Many readers are sending their feedback/comments on several issues and the column has become popular. Monthly about 1650 copies are mailed. About 200 non-members also subscribe to it.

The Association is conscious of the fact that the journal, however popular it might seem to be, still has scope for improvement in its content, print layout and especially in its literary and journalistic standards. We welcome suggestions from our readers in this regard. 11.3. From last year, the Association has been giving information about the outstanding achievements of our members in various fields. In October 2017 issue, a write up on Shri R.Soundararajan, LM 710, appeared on his winning the first prize in letter writing competition conducted by India Post about Mahatma Gandhi. He was conferred with the title "Patron of Post". In the same issue, the achievement of Shri S.K.Mhaskar, ALM 2207, residing in Pune, in the service of pensioners was published. In November 2017 issue, articles on Shri B.S.Ramamurthy, LM 2778 and Shri K.K.Gangadharan, LM 1717, were published.

12. Membership and Finance.

12.1 Our membership is increasing and has now reached 2630. New members enrolled during the year are 123. However, the members are again requested to persuade their excolleagues to become members when they retire, as it is noticed that not all pensioners even from the Postal Department join the Association. Recently, we requested the nonmembers, who subscribe to Pensioners' Champion, to become members. In January 2018 issue, an appeal to enroll the friends/ relatives of members was made, providing the application form. The response is encouraging. 12.2. Though we are receiving a good amount of donations from members and well-wishers for the 'Building Fund', many are still to respond. A portion of the 'Pensioners' Bhavan' is let out. The rents from it, the interest from the fixed deposits and donations have enabled the Association to manage its finances. We sincerely thank all these individuals. All their names are published in *Pensioners' Champion*.

12.3. SBI, Vidyaranyapura, had deducted a sum of Rs.21235 from 2 accounts of the Association, stating that the Association is not eligible to open Savings Bank accounts as per orders from the Reserve Bank of India issued in 2004. Our SB accounts were converted into current accounts in 2016. The Association wrote to the bank stating that, since SB accounts were in existence from 2014 to 2016, interest already paid to us cannot be recovered. As the Bank did not agree, the Banking Ombudsman was approached in November 2017. In March 2018, the complaint was disposed of in our favour and the amount recovered from us was credited back to our account.

- 12.4 . The Association has been keeping the building fund in short term Fixed Deposits, so that it can earn some interest.
- 12.5. The Association donated Rs.5000 towards the Building Fund of Udayabhanu Kalasangha, Gavipuram, Bengaluru, who are expanding their building, in gratitude for their lending the hall free of cost to all the functions of CCCGPA.

The respect that Sri Vittal Rao commands with all of his former colleagues and acquaintances played a major role in hundreds of donors readily responding to his appeal.

As promised last year, we are meeting at the New Annexe to Pensioners' Bhavan for the Annual General Body Meeting. But, as it generally happens, the building cost has exceeded the estimate. We had hoped that it would be only to a small extent. Though the original estimate made in 2016 was Rs.50 lakh, it is now nearly Rs.60 lakh, mainly due to the recently introduced GST. Therefore, we are once again requesting for generous donations, especially from those members, who have not donated yet.

As you are aware, every Central Government Pensioner/Family Pensioner is required to submit a Life Certificate to the Pension paying Bank in the month of November for uninterrupted payment of pension. This process sometime turns out to be painstaking for aged pensioners, who are not able to go to the bank Branch due to ill health or other reasons.

- 2. You may also be aware that the Government has extended additional facility of submission of Life Certificate in Digital mode. This facility of submission of Digital Life Certificate can be availed online even from the comfort of Home.
- 3. With a view to provide facility to the aged pensioners /family pensioners (say to those above the age of 75 years) from their Home, this Department intends to take a pilot project by deputing a person with DLS submission Device to the residence of aged pensioners for recording of Digital Life Certificate. In this endeavour the cooperation of Pensioners Associations is expected by way of providing this Department necessary details of the aged pensioners residing in the City of your operation.
