1.5. Registered Office of the Association

The Registered Office of the Association which was located in Banashankari 2nd stage in the residence of Shri N.Bhaskaran, founder Secretary, was relocated at Pensioners' Bhavan, the Association's own building in Telecom Layout, Sriramapura Phase-2, Bengaluru. Necessary amendment to MOA was passed in the Special General Body Meetings held on 22-8-2015 and 10-10-2015. The amendment has also been approved by the

Registrar of Societies.

2. Activities

- 2.1. Portraits of S/s B.Sadashiva Rao, N.Bhaskaran, N.Muthusubramanian, V.S.Gopalakrishnan, M.Ramiah and S.M.Vittal Rao, veterans of the Association were unveiled in the main hall of Pensioners' Bhavan on 11-4-2015 in recognition of their invaluable service to the Association. Report appeared in Pensioners' Champion, April-2015 issue.
- 2.2. Sri S. C. Maheshwari, Secretary General, Bharat Pensioners Samaj, New Delhi, was the Chief Guest in the AGB held on 21-6-2015. Sri MM Kapur, Editor, Bharat Pensioner and Shri MRV Nath Vice President, AIFPA Chennai, were the Guests of Honour. 60 Members of 75 years and above were honoured in the AGB. Cash awards of Rs. 1000/- each were distributed to six Meritorious Students of Govt. Primary School, Yelahanka.
- 2.3. In a rare gesture, Shri N.Bhaskaran, Founder Secretary and Permanent Advisor to the Association was honoured by Karnataka State Retired Employees' Association in coordination with Banks, Apollo Pharmacy and the Government of Karnataka on 25.6.2015. Another Member, Smt.Nagamani S. Rao was awarded with the prestigious "Karnataka Rajyotsava Award 2015" in recognition of her contribution in media and journalism on 1.11.2015. The Association congratulates both.

2.4. Seventh Central Pay Commission

(i) The 7th Central Pay Commission, constituted on 28-2-2014, submitted its report to the Central Government on 19-11-2015. As far as pensionary benefits are concerned, there is no change in the rates of Pension & Family Pension, Age-related Additional Pension, Encashment of leave, Commutation and Fixed Medical Allowance, formula for grant of Dearness Relief etc. However, on the demand for parity in pension, the Pay Commission has recommended

notional fixation of Pay after adding the number of increments earned in that level while in service and determination of pension on the notional pay. Though it does not actually amount to complete parity in pension as demanded by us, it is better than the previous CPC recommendations. The Association has given extracts of some of the paras of the report along with illustrations on computation of revised pension in several issues of *Pensioners' Champion*

- Department of Pension & PW had (ii) called for the views of the Association on the recommendation of the Pay Commission. In response, the Association vide its letter dt. 17-12-2015 conveyed its views pointing out various anomalies, giving live examples. As a follow-up, a meeting of experts of various Departments was called for in this connection on New Year's Day, in which views expressed by the Association were fully endorsed. A Memorandum was submitted on 18.1.2016 to the Cabinet Secretary, Chairman of the **Empowered Committee of Secretaries** constituted to process 7th CPC recommendations. Contents of the letters were reproduced in *Pensioners*' Champion Dec 2015 & Jan 2016 issues.
- (iii) The latest position is that, since Assembly elections to 4 States and a Union Territory are due in May 2016, Government's decision will be known only after that, perhaps in June.

2.5. **BSNL**

We submitted a Memorandum to the Cabinet Secretary, Chairman of the Empowered Committee of Secretaries constituted to process 7th CPC recommendations on extension of recommendations of 7th CPC to BSNL Pensioners and application of same fitment formula for revision of their pension on par with Central Govt. Pensioners. The

Memorandum has been reproduced in *Pensioners' Champion* February, 2016 issue.

2.6. Standing Committee of Voluntary Agencies (SCOVA)

The Association is proud to announce that KP&TPA has been re-nominated to the SCOVA for another 2 years 2015-17 in the Rotating Group. As before, many items for discussion suggested by the Association have been included in the Agenda and positive results have also been seen. In the 27th SCOVA meeting held on 13-10-15, two items suggested by our Association were included.

- i). Modification to the Life Certificate format i.e. for inclusion of acknowledgement in the format. On our suggestion revised format was issued.
- ii). Extension of full pension to Pensioners with less than 33 years of service. CAT Benches and also various Courts including the Apex Court have passed favourable judgements in favour of Pensioners. We are extremely happy to note that the Government has finally agreed to implement the Orders of the Courts and an O M has been issued by DoP&PW on 6-4-2016 granting full pension to all pre-2006 Pensioners irrespective of the number of years of service. With the issue of this OM, grant of pro-rata pension for less than 33 years of service stands dispensed with. OM dated 6-4-2016 is reproduced in April 2016 issue of Pensioners' Champion. Illustrations on computation of arrears of pension for the period from 1-1-2006 to 31-12-2015 are also given in the journal.
- iii). The Association had sent 5 items for discussion in the 28th Meeting of SCOVA scheduled to be held on 16-5-2016. Details of the items are published in March 2016 issue of Pensioners' Champion

3. Charitable Works

3.1. Donation to Prime Minister's National Relief Fund

A sum of Rs.10,000 was contributed to PMNRF- Nepal Earthquake Relief Fund - by the Association in May 2015

3.2. **TNCRF**

Our appeal to the Members through the journal *Pensioners' Champion* for donations to the TNCRF, to come to the help of flood affected people in Chennai, Tamil Nadu, devastated by torrential rains, evoked good response from our Members. A sum of Rs.80,000/-, including the Association's contribution, was remitted to the Joint Secretary & Treasurer, Tamil Nadu Chief Minister's Relief Fund, Chennai on 21-3-2016.List of donors and copy of the cheque were published in *Pensioners' Champion* March 2016 issue. and copy of the receipt in April 16 issue.

3.3. Encouragement to Students

Like every year, the Association arranged a function in Government Primary School, 4th Phase, Yelahanka New Town, Bengaluru this year also on 6.2.2016. Cakes, fruits, writing materials were distributed among the children. Students exhibited their skills in cultural programme arranged on the occasion. A report with photos appeared in February issue of *Pensioners' Champion*. In the last AGB on 21.6.2015, cash award of Rs.1000/each was given to six Meritorious Students of the same School.

Our thanks to Sri S.M.Vittal Rao, Internal Auditor, for donating a sum of Rs.8000/- to meet the expenditure in connection with the function.

3.4. Providing meal to Cancer Patients

Free Lunch was served to the Cancer Patients at Kidwai Memorial Institute of Oncology, Bengaluru on 17-12-2015 from the Donations made by the Association to the Institute.

4. Other Activities

4.1 International elder's day

The Association actively participated in the International elder's day on 1-10-2015. Gave wide publicity to Memory Screening camp conducted by CGHS in coordination with NIMHANS on 22-9-15 at Shruthi Auditorium, Kendriya Sadan, Koramangala, Bengaluru. A detailed report was published in *Pensioners' Champion* September 2015 issue.

4.2. E C Meetings

The Executive Committee of our Association met on every 2nd Saturday of the month during the year in Pensioners' Bhavan, the Association's own building.

4.3 Pensioners' Day was observed on 21st December, 2015 jointly by our Association and Coordination Committee of Central Government Pensioners' Associations, Karnataka. Dr. Kishore Kumar, Sr.CMO(HQ) and Dr. Rvindra Y Asangi, CMO (HQ) were the Chief Guests. An interactive session on facilities available to CGHS Beneficiaries was conducted in which several Beneficiaries participated

5. Health

- (a) In coordination with CCCGPA, Karnataka, a lecture by Dr. R P Joshi, CMO, CGHS on the subject "Leading a healthy life after 60 years" was arranged on 31-5-2015 at Udaya Bhanu Kala Sangha, Bangalore.
- (b) Health awareness programme was conducted on 27-3-2016 in coordination with CCCGPA, Karnataka. Dr. R P Joshi, CMO, CGHS delivered a lecture on "Diabetes and Hypertension- Prevention and Management" with power point presentation
- (c) Apollo Pharmacy offered discount on medicines to the Members of KP&TPA @ 11% on medicines; 5% on FMC products and 15% on Apollo label products.

6. Pensioners' Welfare activities

6.1. Grievances of some of our Members regarding delay in payment of pension on pension disbursement days, non-revision of pension in terms of OM dated 28-1-2013 and 30-7-2015, were taken up with the Authorities concerned and settled to the satisfaction of our Members. A few family members of the deceased Pensioners were assisted by the Association in submitting applications for Family Pension.

6.2. Issue regarding Payment of arrears of pension to pre 2006 Pensioners consequent on issue of OM dated 30.7.15 was taken up with Director of Accounts (Postal), Karnataka & Controller of Communication Accounts, DoT, Karnataka, requesting them for early release of arrears. Sr. Accounts Officer, O/o DA (P), Bengaluru ensured payment of arrears to all 689 Postal Pensioners before 31.8.15. CCA, DoT also ensured payment in Nov 2015 notwithstanding large number of cases that had to be reviewed. Association wishes to thank DA (P) and CCA, DoT/BSNL, Bengaluru, particularly, Smt. N.Nagalakshmi, Sr. AO O/o DA(P), Bengaluru.

We thank Sri P.Gangadhara Rao, Dy.General Secretary, and Sri Changappa, Circle Secretary, AIBSNLPWA, for the support extended by them in connection with payment of arrears of pension to pre 2006 DoT Pensioners.

- 6.3. In the AGB dated 21.6.15, a Representative of LIC spoke about the 'Varishta Pension Bima Yojana' under which Pensioners could deposit their savings to earn monthly interest. He distributed pamphlets and answered queries from Members
- 6.4. Director of Accounts (Postal), Bengaluru has taken a new initiative by introducing a proforma in which all Postal Pensioners were asked to furnish their addresses and other particulars so as to enable DA(P) to send the revised PPOs in connection with revision of pension as a result of the 7th CPC directly to

the Pensioners. KP&TPA gave wide publicity to this by furnishing an extract of the Proforma in October 2015 issue of *Pensioners' Champion*. We are grateful to DA(P) for taking this new initiative in the interest of Pensioners' welfare.

7. CGHS matters

- (a) In its Order dated 8.6.2015, MoH&FW decided that Plastic Cards for CGHS Beneficiaries will be delivered through Wellness Centres instead of Speed post. Additional Director, CGHS intimated that a large number of these Plastic Cards were lying uncollected at WCs and our Association made an appeal to the Beneficiaries through the journal to collect them. The order dated 10.7.15 regarding linking Aadhar number to CGHS facility was also circulated through the journal.
- (b) At the start of the year 2015, only 5 Hospitals in Bengaluru were empanelled under CGHS, most of the erstwhile Empanelled hospitals having withdrawn the service, citing low package rates and pending bills. Due to the efforts of all stake holders concerned, including KP&TPA and CCCGPA, now 16 Hospitals, 6 Diagnostic Centres, 33 Eye Care Hospitals and 4 Dental Clinics are empanelled under CGHS in Bengaluru.
- (c) Extension of CGHS facility to P&T Pensioners: Ministry of Health and Family Welfare vide its OM dated 1-8-1996 had denied CGHS facility to P&T Pensioners who were not participating in CGHS while in service. KP&TPA had included this issue in the Memorandum submitted to the 7th CPC. Memorandum was submitted to the Minister of Health &FW. The Secretary, along with GS, CCCGPA, met the Secretary of CGEWCC & Commissioner Income tax and requested him to use his good offices to settle CGHS problems

like issue of permanent cards to P&T Pensioners. The issue was also notified for discussion in the 27th meeting of SCOVA held on 13-10-2015. As a result of all these efforts MoH &FW has agreed to consider this demand.7th CPC also has recommended that all Postal Dispensaries should be merged with CGHS and all P&T Pensioners, irrespective of their participation in CGHS while in service, can avail CGHS after making suitable subscriptions.

(d) Pensioners of Autonomous Bodies like Coffee Board, Tea Board, Silk Board etc. have not been extended CGHS benefits now. The Pensioners' Associations of all these bodies have been struggling for this for a long time. The first convention of Pensioners & Family Pensioners of those Associations was held on 3-4-2016 in which a Memorandum was submitted to Sri P.C.Mohan, Member of Parliament, Lok sabha, requesting him to cause extension of Medical Facility to the Pensioners. The Hon'ble MP assured his support and volunteered to lead a delegation of the Representatives of Pensioners to meet the Hon'ble Minister of Health & FW in this connection.

KP&TPA extends its wholehearted support to those Associations in achieving their reasonable & justified demand.

(e) The Secretary along with Sri S.Radhakrishna, GS, CCCGPA attended meetings with AD, CGHS on 10.9.15 and 6.11.15 to discuss CGHS matters. Visited HMT Hospital and HMT Bhavan on 19.10.15 in connection with relocation of Wellness Centre 9 Gangenahalli in a spacious building. The issue is still to be resolved. We wish to place on record the support extended by Sri S.Radhakrishna, Gen.

Secretary, CCCGPA, Karnataka, Dr. Anjali Rao, Additional Director, CGHS, Dr. Kishore Kumar, Sr.CMO(HQ) & Dr.Raveendra, CMO, O/o AD, CGHS, and Sri N.Bhaskaran, Advisor, K P&TPA & CCCGPA in ensuring settlement of the problem of shortage of Hospitals faced by CGHS Beneficiaries.

8. Our role in connection with "Pensioners' Portal"

Ours is one of the Pensioners' Associations identified by the Department of Pension & Pensioners' Welfare under "Pensioners' Portal"- a mission mode project under National e- Governance Plan (NeGP). We have received Rs.73,073/- as Grant-in- Aid for the year 2015-16.

During the year we registered a few grievances of our Members online with Pensioners' Portal making use of the CPENGRAMS - the grievance redress and monitoring system. All the grievances registered by us were redressed by the Departments concerned.

9. Our relationship with Dept of Pension &PW

Our relationship with the Department of Pension & PW was extremely cordial .Many items suggested by us for inclusion in the agenda of SCOVA meetings were considered and some of them were accepted and Orders issued. We gave wide publicity to the Circulars issued by DoP&PW on subjects like seeding of Aadhaar numbers with pension SB accounts, Registration of Pensioners with Jeevan Pramaan Portal for getting Digital Life Certificates etc. In coordination with Bangalore GPO we conducted special camp for Digital Life Certificates. We addressed Heads of All Public Sector Banks seeking their support in seeding of Aadhaar number in pension SB accounts of Pensioners. We have submitted a detailed report in this connection to DoP&PW.

10. Our Website

Our website www.kptpa.org has been maintained for 4 years. Our monthly journal Pensioners' Champion is being uploaded to the Website every month. We request our Members to visit the site regularly and give suggestion for improvement, which will always be welcome. We feel that there is scope for further improvement in the content of the website and the format also needs a change to make it more attractive. We request the computer savvy Members to render their service to the Association in this regard.

11. Our Publications

- (i) The 8th edition of 'Compendium on Pension, CGHS for Central Government and BSNL Pensioners' has proved to be popular. Postal Department has been giving copies to the retiring employees as a gift for the past few years. Income Tax Department, Central Excise &Customs, DoT/BSNL and some other Departments are also purchasing the books from us. Copies are available for sale in 'Post Shoppe' at Bengaluru GPO, S S Book Emporium and Book Centre. We propose to bring a supplement when 7th CPC recommendations are implemented by the Govt.
- We continued to publish our monthly journal Pensioners' Champion. The journal carries all important information of not only P&T but other Central Government establishments, which the Pensioners may find useful. All the activities undertaken by the Association find a place in the journal. Reports on meetings like SCOVA meetings, CGHS meetings, charitable functions, etc. are published. There are regular columns on CGHS, BSNL, AICPI and Legal matters. This year we have been giving updates on 7 th CPC also. It has proved popular amongst Pensioners in other places also and about 1600 copies are

mailed every month. As per the decision taken in the last AGB meeting, the subscription for the said journal has been raised to Rs.120/- for Members and to Rs.150/- for Non-members with effect from 1.8.2015. We have tried to keep the increase in subscription to the bare minimum in spite of increasing cost of printing.

12. Membership and Finance

- i. Our Membership has now reached 2388. 124 new Members have joined in the current year. A good number of donations are being received from Members and well wishers regularly. The Association sincerely thanks all these individuals. All their names are published in the journal.
- ii. A portion of the Pensioners' Bhavan is given on rent. That apart, interest earned from the Fixed Deposits and liberal donations have enabled the Association to manage its financial needs and balance the fiscal position. However, during the year we had to withdraw Rs. 6.00.000/- from the Fixed Deposits to meet the expenditure in connection with purchase of site allotted to us by the Telecom Housing Society. Expenditure for holding the AGB is likely to be on the higher side this year due to change in the venue of the AGB and increase in the number of Members to be felicitated. We have to necessarily think of finding new resources to further strengthen the finances of the Association.
- iii. Audited Statement of Accounts and Balance Sheet for the year 2015-16 are appended to this Annual Report.

Full Pension for less than 33 years

Revision of pension of pre-2006 Pensioners - delinking of revised pension from qualifying service of 33 years.

O.M.No. 38/37/08-P&PW (A) dated 6th April, 2016. Gol, Ministry of Personnel, PG & Pensions, Department of Pension & Pensioners' Welfare

The undersigned is directed to say that as per Para 4.2 of this Department's OM of even number dated 1.9.2008 relating to revision of pension of pre-2006 Pensioners w.e.f 1.1.2006, the revised pension w.e.f. 1.1.2006, in no case, shall be lower than 50% of the sum of the minimum of Pay in the Pay Band and the Grade Pay thereon corresponding to the pre-revised pay scale from which the Pensioner had retired. A clarification was issued vide DoP&PW OM of even number dated 3.10.2008 that the pension calculated at 50% of the minimum of Pay in the Pay Band plus Grade Pay would be calculated at the minimum of the pay in the pay band (irrespective of the prerevised scale of pay) plus the Grade Pay corresponding to the pre-revised Pay Scale.

- 2. Several petitions were filed in the Central Administrative Tribunal, Principal Bench, New Delhi inter alia claiming that the revised pension of the pre-2006 Pensioners should not be less than 50% of the minimum of the Pay Band + Grade Pay, corresponding to the pre-revised Pay Scale from which Pensioner had retired, as arrived at with reference to the fitment tables annexed to Ministry of Finance, Department of Expenditure OM No. 1/1/2008 IC dated 30th August, 2008. Hon'ble CAT, Principal Bench, New Delhi vide its common order dated 1.11.2011 in OA No.655/2010 and three other connected OAs directed to re-fix the pension of all pre-2006 retirees w.e.f. 1.1.2006 based on the Resolution dated 29.8.2008 of the Department of Pension & Pensioners' Welfare and in the light of the observations of Hon'ble CAT in that order.
- 3. Orders were issued vide this Department's OM of even number dated 28.1.2013 for stepping up of pension of pre-2006 Pensioners

- w.e.f. 24.9.2012 to 50% of the minimum of Pay in the Pay Band and Grade Pay corresponding to pre-revised pay scale from which the Pensioner retired. Para 5 of this OM provides that in case the consolidated pension/family pension calculated as per para 4.1 of O.M. No.38/37/08- P&PW (A) dated 1.9.2008 is higher than the pension/family pension calculated in the manner indicated in the O.M. dated 28.1.2013, the same (higher consolidated pension/family pension) will continue to be treated as basic pension/family pension.
- 4. Subsequently, in compliance of the Order dated 1.11.2011 of the Hon'ble CAT, Principal Bench in OA No. 655/2010, order dated 29.4.2013 of Hon'ble High Court of Delhi in WP (C) No. 1535/2012 and Order dated 17.3.2015 of Hon'ble Supreme Court in SLP (C) No. 36148/2013, Order was issued vide this Department's OM of even number dated 30.7.2015 that the pension/family pension of all pre 2006 Pensioners/Family Pensioners may be revised in accordance with this Department's O.M. No.38/37/08-P&PW(A) dated 28.1.2013 with effect from 1.1.2006 instead of 24.9.2012.
- 5. In accordance with the Order issued in implementation of the recommendation of the 6th CPC, the pension of Government servants retired/retiring on or after 1.1.2006 has been delinked from qualifying service of 33 years. In OA No. 715/2012 filed by Shri. M.O. Inasu, a pre-2006 Pensioner, Hon'ble CAT, Emakulam Bench, vide its order dated 16.8.2013 directed that the revised pension w.e.f. 1.1.2006 under para 4.2 of OM dated 1.9.2008 would not be reduced based on the qualifying service of less than 33 years. The appeals filed by Department of Revenue in the Hon'ble High

- Court of Kerala and in the Hon'ble Supreme Court have also been dismissed. Similar Orders have been passed by Hon'ble CAT/ High Court in several other cases also.
- 6. The matter has been examined in consultation with the Ministry of Finance (Department of Expenditure). It has now-been decided that the revised consolidated pension of pre-2006 Pensioners shall not be lower than 50% of the minimum of the Pay in the Pay Band and the Grade Pay (wherever applicable) corresponding to the prerevised Pay Scale as per fitment table without pro-rata reduction of pension even if they had qualifying service of less than 33 years at the time of retirement. Accordingly, Para 5 of this Department's OM of even number dated 28.1.2013 would stand deleted. The arrears of revised pension would be payable with effect from 1.1.2006.
- 7. 'Ministry of Agriculture, etc. are requested to bring the contents of these Orders to the notice of Controller of Accounts/Pay and Accounts Officers and Attached and Subordinate Offices under them for revising the pension of all those pre 2006 Pensioners who had rendered less than 33 years of qualifying service at the time of retirement in the manner as indicated above on top priority. Revised Pension Payment Orders in all these cases may also be issued immediately.
- 8. All pension disbursing Offices/Banks are also advised to prominently display these Orders on their notice boards for the benefit of Pensioners.
- 9. This issues with the approval of Ministry of Finance, Deptt. of Expenditure vide ID Note No. 2(9)/EV/2015, dated 15.3.2016.
- 10. Hindi version will follow.

News from Sister Associations

All India Postal Pensioners' Association, Ananthapuramu, AP

The 33 rd Annual General Body Meeting of the Association was held on 24-1-2016 under the President ship of Sri Y.R.Krishna Murthy. About 120 Members attended. Secretary, Sri K.Subbarayudu presented the annual report. The President spoke on 7th CPC report and explained its salient features.42 Members who had completed 75/80 years of age were felicitated on the occasion.

C.S.D. Canteen Facility

Grant of CSD Canteen Facilities to Retired Defence Civilian Employees

Office order No. F.No.8(14)/2015-D(Mov) Gol, Ministry of Defence, Dated the 4th March, 2016.

In continuation of this Ministry's Office Order of even No. dated 31st July, 2015 on the above mentioned subject, the undersigned is directed to say that with the approval of Hon'ble RM, it has been decided that the Family pensioners of retired Defence Civilian Employees will also be eligible for extended CSD Canteen facilities.

Revision of pension of Pre-2006 Pensioners with less than 33 years of service on par with post 2016 Pensioners – a case won!

The Background

The modified parity in pension between pre-2006 & post -2006 Pensioners recommended by the 6th Central Pay Commission in para 5.1.47 of its report was implemented partially consequent upon issuance of O M No.38/37/08-P&PW(A) dated 30th July, 2015 read with OM dated 28-1-2013 by the Department of Pension & Pensioners' Welfare. However, the recommendation needed its implementation in letter and spirit by further liberalisation of the provisions of OM dated 28-1-2013 by extending the benefit to pre-2006 Pensioners with less than 33 years of service & also to Pensioners who retired from Upgraded posts.

The 6th Pay Commission had recommended that" in order to maintain the existing modified parity between present and future retirees,..... The fixation... will be subject to the provision that the revised pension, in no case, shall be lower than 50% of the sum of the Minimum of the Pay in the Pay Band and the Grade Pay thereon Corresponding to the pre revised Pay Scale from which the Pensioner had retired ". DoP & PW, in its OM dated 1-9-2008 did incorporate the recommendation on modified parity verbatim - in para 4.2. But, the clarificatory Orders issued subsequently vide OMs dated 3-10-2008 and 14-10-2008 were not in consonance with the recommendation of 6th CPC.

The Central Administrative Tribunal, Principal Bench, New Delhi, in OA 655/2010, in its order passed on 1-11-2011, quashed and set aside DoP&PW O.M. dt. 3-10-2008, clarificatory O.M. dated 14-10-2008 and O.M. dated 11- 2-2009, and directed the Government to re-fix pension of all pre-2006 retirees w.e.f. 1-1-2006 based on the resolution dated 29-8-2008. The issue attained finality with the

dismissal of SLPs by the Hon'ble Supreme Court on 17-3-2015 and the DoP&PW issuing OM No.38/37/08- P&PW(A) dated 30th July, 2015 ordering implementation of the provisions of its OM dated 28-1-2013 from 1-1-2006 itself instead of 24-9-2012. Thus the revision of pension and family pension as envisaged in para 4.2 of OM dated 1-9-2008, issued in implementation of the recommendations of 6th CPC, was partially complied with, since the condition of the requirement of 33 years of service for computation of revised pension at 50 % of the emoluments in terms of para 4.2 had not been removed . Hence, the revised pension of pre 2006 pensioners with less than 33 years of service was reduced pro rata depending upon the number of years of their service.

The demand for grant of full pension, irrespective of completion of 33 years of service, on par with post 2006 Pensioners, was vigorously pursued by Pensioners' Associations and Employees Unions in several fora and by many Pensioners through filing Applications before CAT benches. All judicial pronouncements were in favour of the Applicants. Karnataka P&T Pensioners Association notified this issue for discussion in the 27th meeting of SCOVA held on 13-10-2015.DoP&PW informed the Association that the matter was under active consideration. (Details in pages 3&4 of *Pensioners Champion*- September 2105 and pages 5&6 of October 2015 issue)

Finally, as result of the combined efforts of all stake holders and with the intervention of the Judiciary as also the issue having attained legal finality, DoP&PW liberalised the provisions of its OM dated 28-1-2013 on modified parity in pension and deleted para 5 of the OM which had linked pension with 33 years of service.

With the issue of OM dated 6-4-2016

the long pending demand of pre-2006 Pensioners - with qualifying service of less than 33 years of service - for grant of full pension on par with post 2006 pensioners gets resolved. However, the grievance of pre-2006 Pensioners for revision of their pension with reference to the pay scale of the **post from**

which they had retired which were upgraded subsequent to their retirement is still to be redressed.

Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 1.1.2016.

O.M. No. F.No. 42/06/2016-P&PW(G) dated 11th April, 2016 Gol, Ministry of Personnel, Public Grievances & Pensions Department of Pension & Pensioners' Welfare

The undersigned is directed to refer to this Department's OM No.42/10/2014-P&PW(G) dated 28th September, 2015 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief (DR) payable to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 119% to 125% w.e.f 1st January, 2016

- 2. These Orders apply to (i) All Civilian Central Government Pensioners/Family Pensioners (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners (iv) Railway Pensioners and (v) The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government pensioners from Pakistan, who are Indian Nationals but receiving pension on behalf of Government of Pakistan and are in receipt of ad-hoc ex-gratia allowance of Rs. 3500/- p.m. in terms of this Department's OM No. 23/1/97- P&PW(B) dated 23.2.1998 read with this Department's OM No. 23/3/2008-P&PW(B) dated 15.9.2008.
- 3. Central Government Employees who had drawn lump sum amount on absorption in a PSU/ Autonomous body and have become eligible to restoration of 1/3rd commuted portion of pension as well as revision of the restored amount in terms of this Department's OM No. 4/59/97-P&PW (D) dated 14.07.1998 will also be entitled to the payment of DR @ 125% w.e.f. 1.1.2016 on full pension i.e. the revised pension which the absorbed employee would have received on the date of restoration had he not drawn lump sum payment on absorption and Dearness Pension subject to fulfilment of the conditions laid down in para 5 of the O.M. dated 14.07.98. In this connection, instructions contained in this Department's OM No.4/29/99-P&PW (D) dated. 12.7.2000 refer.
- 4. Payment of DR involving a fraction of a rupee shall be rounded off to the next higher rupee.

- 5. Other provisions governing grant of DR in respect of employed family pensioners and reemployed Central Government Pensioners will be regulated in accordance with the provisions contained in this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended vide this Department's OM No. F. No. 38/88/2008-P&PW(G) dated 9th July, 2009. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 6. In the case of retired Judges of the Supreme Court and High Courts, necessary Orders will be issued by the Department of Justice separately.
- 7. It will be the responsibility of the Pension Disbursing Authorities, including the Nationalized Banks, etc. to calculate the quantum of DR payable in each individual case.
- 8. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, 11/34-80-11dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 9. In their application to the pensioners/family pensioners belonging to Indian Audit and Accounts Department, these Orders issue after consultation with the C&AG.
- 10. This issues with the concurrence of Ministry of Finance, Department of Expenditure vide their OM No. 1/1/2016-E.II(B) dated 7th April, 2016.
- 11. Hindi version will follow.

OA 1165/2011, OA 2165/2011 and OA 247/2012 with MA 265/2015 &2353/2014, before CAT Principal Bench, New Delhi.— Application allowed on 21-4-2015 - Extract of relevant paras given in page-11 of *Pensioners' Champion*, May 2015 issue.

3. Grant of full pension to pre-2006 Pensioners who had retired on superannuation & on absorption in PSUs with 10 years of qualifying service

RA 165/2015 & RA 172/2015 before CAT, PB New Delhi – Application allowed; Order pronounced on 22-1-2016. Extract of the operative Para given in page 6 of *Pensioners' Champion* Feb 2016 issue. Uol has reportedly, filed a writ petition in the High Court of Delhi.

Note: Department of Pension & PW has since issued an order vide its OM dated 6-4-2016 delinking revised pension from 33 years of service in respect of pre-2006 Pensioners. Hence, all pre 2006 Pensioners with less than 33 years of service are now entitled to pension at 50% of the sum of the minimum of the Pay in Pay Band and Grade Pay thereon as indicated in column No 9 of the concordance table annexed to OM dated 28-1-2013. DoP&PW OM dated 6-4-2016 is reproduced in page 15 of this journal.

4. Complete parity in pension between pre-2006 & post- 2006 retirees of grade S -30.

OA.937/2010 filed by All India S-30 Pensioners' Association & OA 2101/2010 were allowed by a common Order passed by CAT, Principal Bench, New Delhi, on 20-11-2014. Extract of the Order given in page 4 of Pensioners' Champion- December 2014.

Review Application No. RA 10/2015 filed by S-30 Pensioners' Association was disposed of by an Order passed by the CAT on 24-9-2015 wherein it has been ordered that "the basic pension of pre-2006 retirees in S-30 should be fixed such that it is not less than Rs.38,500/." Extracts of the pars of the operative part of the judgement given in pages 7-8 of October 2015 issue of *Pensioners' Champion* Uol has filed a Writ Petition in the Hon'ble High Court of Delhi. Case No.WP(C) 5327/2015. Next date of hearing 19-5-2016.


