PENSIONERS PROTEST

For the first time in the recent past. Pensioners' Associations affiliated to the Coordination Committee of Central Government Pensioners' Associations, Karnataka held an impressive demonstration in Bengaluru on 16-3-2017 in solidarity with the Central Govt Employees who were on strike under the banner of Confederation of CG Employees and Workers demanding acceptance of 21 demands included in the 'charter of demands 'given to the Govt along with the strike notice on 28-12-2016. The demands, inter alia, included the demands concerning pensioners also. Important of them are (1) Implementation of option I, the only positive recommendation of 7th Central Pay Commission for pre-2016 pensioners. (2) Implementation of the 7th CPC recommendations to pensioners of Autonomous bodies and (3) Cashless medical treatment to all Central Govt employees and pensioners in all Government and recognised Private Hospitals.

The Central cabinet had accepted both the options I & II recommended by the Pay Commission on revision of pension of pre-2016 pensioners with a rider of examining the 'feasibility' of implementation of option-1 by a Committee constituted for the purpose. The Committee headed by the Secretary Department of Pension & PW, has reportedly recommended rejection of option- I and has suggested a new formula based on parity in pension recommended by 5th CPC. Staff side and Pensioners' Associations including Karnataka P&T Pensioners' Association, an affiliate of CCCGPA, Karnataka had demanded that the new formula suggested by the Committee, can be considered as another option (3rd option) in addition to the other 2 options recommended by the 7th CPC. Although the new formula, may be advantageous, to pensioners who had been promoted to higher posts at the fag end of their service, it may not benefit a large numbers of pensioners who had retired post 2006 after earning several increments in the pay scale

from which they had retired. Keeping all these facts in view, Confederation of CG Employees and workers included the issue of implementation of option I in its Charter of demands for strike.

Government of India, vide its resolution dated 4th August 2016, accepted the recommendations of the 7th Central Pay Commission on pensionery benefits and all the Central Govt Civil Pensioners have been granted the benefits of revised pension with retrospective effect from 1-1- 2016 and the arrears of pension due was also paid to them on 31-8-2016 along with their revised pension for the month of August 2016. But, in spite of elapse of 7 months, the benefits of 7th CPC recommendations have not yet been extended to Pensioners of Statutory & Autonomous bodies like Coffee Board, Rubber Board, Tea Board, Spices Board Tobacco Board, Kendriya Vidyalaya Sangathan, Khadi & Village Industries Commission, Central Silk Board and National Council of Science Museum.

All these Autonomous bodies were constituted by Acts of Parliament and they have been following the Service Rules and Pension Rules framed by the Central Govt as amended from time to time. Modifications to CCS (Pension) Rules, 1972 introduced in the past on the recommendations of Central Pay Commissions were extended by the Autonomous bodies to their Employees and Pensioners; age related additional pension recommended by 6th CPC, is an example. The inordinate delay in implementation of 7th CPC benefits to them was taken up by the CCCGPA with the PMO in Nov 2016 and the Confederation of CG Employees & Workers was also requested to include this demand in the Charter of Demands. Though Orders were issued on 13-1-2017 and 10-2-2017, the provisions of DoP&PW OM dated 4-8-2016 on revision of pension of pre-2016 pensioners, have not vet been extended to the Pensioners

of Autonomous bodies. Even the increase in Dearness Relief due from 1-7-2016 has not been paid to them.

The Management Committee of CCCGPA, Karnataka in its meeting held on 20-2-2017 decided to hold a demonstration on 16-3-2017 to extend solidarity to the striking Central employees and to urge the Govt to accept the above said demands of pensioners.

In the demonstration held at Freedom Park, Bengaluru, about 12 Pensioners' Associations affiliated to CCCGPAs and about 250 pensioners were present. A galaxy of trade union leaders, past & present, extended their support to the pensioners by their presence in the venue throughout the proceedings. As a gesture of comradeship, many serving employees especially from the RMS, who were on strike, joined the pensioners in the demonstration.

Sri S.Radhakrishna, General secretary, CCCGPA after welcoming all those present in the venue, spoke about the demands and the unhelpful attitude of the Govt. in resolution of the grievances of the employees in general and the pensioners in particular, which has compelled even the pensioners to resort to agitations to get their just demands accepted by the Govt. He was apprehensive about acceptance of the new pension revision formula reportedly suggested by the Pension Committee in place of Option-1 recommended by the 7th CPC.

Sri K B Krishna Rao, Chairman, CCCGPA expressed his happiness over the presence of many veteran leaders of P&T Trade Union Movement in the venue, some of whom despite their advanced age, responded to the call of CCCGPA and were participating in the demonstration. He spoke in detail on the demands, the action taken by KP&TPA and CCCGPA and the response of the Department of Pension, Dept of Expenditure and the PMO to the memoranda submitted to them.

Sri P.S.Prasad, General Secretary, Confederation of CG Employees and Workers, Karnataka Unit who addressed the gathering, extended Confederation's support to the pensioners and informed that the strike was successful in the State with the participation of employees of many Central Govt. Departments in the strike.

Sri A.Srinivasa, Circle Secretary, All India RMS&MMS Employees' Union Group-C, Karnataka extending his greetings informed that the strike in RMS offices in the State was near total and some of the offices are closed. He was glad that a good number of pensioners were participating in the demonstration.

Sri N.Bhaskaran, a veteran P&T Trade union Leader, former Circle Secretary, AIRMSEU, Karnataka, who is the founder of K P&T PA & CCCGPA, was reminiscent of the strikes that took place in 1960 & 68 and spoke about the sacrifices of the Trade Union Leaders of his times who were victimised for leading strikes.

Sri G.Babu , President, K P&T PA, and Vice President AIBSNLP WA, who was in the fore front of DoT & BSNL Employees Unions in 1960s and 1970s and lead many struggles while he was in service and is now closely associated with many Educational, Social and Cultural organisations, addressed the gathering and extended his support to the striking employees & pensioners.

Sri Changappa, Circle Secretary, AIBSNLPWA, Karnataka, said that the Govt's intention is to put an end to payment of pension to ever increasing number of Pensioners. Contributory pension scheme *National Pension System* introduced from 1-1-2004, which by no means is beneficial and does not ensure even a minimum guaranteed pension, must be scrapped. He thanked CCCGPA for championing the cause of BSNL pensioners before the 7th CPC.

Sri H S Manjunatha, former Circle Secretary, AIRMSEU, Group-C, Karnataka, speaking about the importance of Employees Unions and Pensioners' Associations in achieving their demands lauded the efforts of CCCGPA, Karnataka in focusing attention on the demands of pensioners and for holding demonstration in pursuance of their demands.

Sri A N Balaram, President, Coffee board Pensioners' Association, a nonagenarian expressed his anguish over the inordinate delay in implementation of 7th CPC recommendations to Pensioners of Autonomous bodies and opined that seeking judicial intervention is not advisable at this stage.

Pensioners' Welfare Association.

Sri TV Suryaprakash, Jt. Secretary, CCCGPA and Secretary Coffee Board Pensioners' Association, who had made all the arrangements for holding the demonstration at freedom park and had coordinated with all the Pensioners' Associations to ensure presence of a good number of pensioners and representatives of Associations, in his speech explained the untiring efforts made by the Associations of Autonomous bodies since August 2016 and emphasised on the need to consolidate the strength of Associations further

to achieve their justified demands. He thanked the Confederation of CG Employees & Works, CCCGPA Karnataka, BPS & NCCCPA for championing the cause of pensioners. The demonstration ended at 1-30 p.m. after vote of thanks proposed by Sri Suryaprakash.

The following Resolutions were passed unanimously

Resolution -1

Pensioners' Associations affiliated to the Coordination Committee of Central Government Pensioners' Association, Karnataka in the Protest Demonstration held on 16th March 2017 at Freedom Park, Bengaluru, here by resolve to strongly urge the Government of India to implement Option-1 recommended by the 7th CPC in para 10.1.67 of its report on revision of pension of pre-2016 pensioners and accepted by the Govt. vide its resolution dated 4th August, 2016 and to consider the new formula reported to have been suggested by the Committee constituted to examine the feasibility of implementation of option-1, as an additional option(option-3).

Pensioners' Associations affiliated to the Coordination Committee of Central Government Pensioners' Association, Karnataka in the Protest Demonstration held on 16th March 2017 at Freedom Park, Bengaluru, having taken notice of the inordinate delay in extension of the provisions of Department of Pension and Pensioners' Welfare OM dated 4.8.2016 which was issued for implementation of the recommendations of 7th Central Pay Commission on revision of pension of pre-2016 Central Civil Pensioners, TO THE PENSIONERS OF STATUTORY/ AUTONOMOUS BODIES, here by resolve to strongly urge the Government of India to immediately order implementation of the 7th CPC recommendations on pension to the pre-2016 pensioners of Statutory/ Autonomous bodies without any further delay.

Meeting a friend, philosopher and guide: a journey to Tamil Nadu

Shri R Soundararajan, now an octogenarian, fondly called 'Vaadhyaar' meaning 'Guru' by his friends, former colleagues and hundreds of his disciples is well-settled in Nagapattinam, a historic town on the east coast of Tamil Nadu. A life member of KPTPA, he retired in 1994 from the Railway Mail Service, a wing of the Department of Posts. He used to make sojourns to Bangalore City to meet his friends and colleagues now and then. One of his visits to the city would usually be in January every year which would enable him to be present in the get-together of RMS & MMS pensioners, arranged by a group of retiree enthusiasts on the first Sunday of the New Year. He could not make it to the last few such get-togethers for some personal reasons. Three of his friends who were eager to meet him, joined by two of his sishyas, set out on a tour of Tamil Nadu on 22 Feb 2017 by a brand-new Hyundai and after visiting a few places en route, reached Nagapattinam, the abode of Vaadhyaar on 23 Feb 2017 to spend some time with him. Sri Soundararajan, in spite of his physical disability, was seen waiting for his visitors at his residence, which is very close to the highway passing through the centre of the town. S/s T Chandrasekaran, B L Channappa, K B Krishna Rao, Rangegowda and TR Shankara Murthy were overwhelmed by the affection showered upon them by Sri Soundararajan and the arrangements made for their overnight stay at the place.

Now let me narrate the story in the first person. He took us around the places of importance in the town and the old sandy beach. He stayed with us till late in the night and guided us through for our next day's tour, giving us information about the places to see, the roads to take and hotels to eat. He was in constant touch with us over phone monitoring our journey and perhaps slept only after ascertaining our safe return to Bangalore late in the night on 24-2-2017 by SUV, owned by

This account will be incomplete if it does not touch at least briefly on the profile of Sri Soundararajan, his exemplary service in RMS, subsequently as a faculty member in Postal Training Centre, Mysore, for 15 years imparting training to hundreds of Postal and RMS staff—operative and managerial, both from India and abroad — guiding and assisting the postal authorities in various fields of activity, his post-retirement contacts with pensioners' associations in Tamil Nadu and Karnataka, his social service in his home town and his pursuit of philately, etc...

Born in Singamangalam, a remote village in Nagapattinam district, Sri Soundararajan had his initial education in nearby villages and then in Nagapattinam town where the family moved after the Second World War. After finishing his high school studies, he did graduation in Hindi and went to Hyderabad for teacher training. As the climate in his home

state was not conducive to Hindi, he chose to work for Railway Mail Service in Bangalore from 1957. While in service he attended evening college and did his master's in English literature, majoring in linguistics. He also obtained diploma in French and Kannada languages with distinction and later did post graduation in Hindi, followed by a translation course of the Ministry of Home Affairs. All this stood him in good stead in developing his writing skill. His essay on *Gandhian Thought and World Peace* (1975) was awarded the first prize by Bangalore University. He won National Solidarity gold medal for his essay *Jawaharlal Nehru*, the *Humanist* (1980).

Multi-faceted jobs

To diversify his job in operative and administrative units of RMS in Bangalore he joined The Postal Training Centre, Mysore. In the new assignment he had to put in strenuous work - nearly 14 hours a day — conducting classroom sessions, editing training manuals/ course materials on various topics, publishing house journals, coordinating with other Central government offices in Mysore in connection with implementation of Hindi as official language and caring for the inmates of the hostel.

With the encouragement of successive heads of the institution, particularly Sri M.P. Rajan, he produced Postal Geography (1993) a unique venture, which was admired by all concerned in the country. The Hindu commented it as a 'fantastic work'. His seminal work was Postal History (1995). For this he had to collect background materials from many countries and several parts of India. The manuscripts relating to India's Post Office secured from the British Library, London, and the microfilms obtained from National Library, Calcutta, were some of the documents which were to be carefully deciphered and incorporated in the book. With much concentration and perseverance he accomplished the task in time. It was an instant success.

He is glad that he could meet about 15,000 students during his stay in the training centre. They were from four southern states and occasionally from other states like Bihar, Bengal and Jammu & Kashmir. Besides, trainees from abroad—mostly from African countries—and, nearer home, from Bhutan and Nepal, underwent specific training programmes. Personnel from Army Post Office and Foreign Post were also deputed to PTC, Mysore, for training. Alongside the nitty-gritty of training Sri R Soundararajan made it a point to inculcate in the trainees ethical values and professionalism.

On return to his home town Sri Soundararajan worked as a columnist for *The Hindu—Young World*. He dealt with geography, a neglected subject, and wrote on postage stamps for the youth. He rendered free service in a college for two academic years with a view to developing communication skills among rural students. His efforts helped them achieve outstanding results on the college work and projects as they began using the language with accuracy and clarity both in speech and writing.

Cleanliness campaign

On finding live germs floating on drinking water collected from a tap in a school Sri Soundararajan was shocked. He began focussing his attention on providing clean drinking water and toilet to students and staff. With the help of another likeminded person he created awareness among the people in this regard by writing to newspapers. School sanitation and hygiene were other priorities he concentrated on. He joined EXNORA International (I E), an NGO functioning as an adjunct to local self-government in solid waste management (SWM) and worked effectively to bring about clean environment in the town. Appreciating the service of EXNORA, the municipal authorities and the management of ONGC offered necessary help to the organisation. Today Nagapattinam, Tirunelveli and Alandur are put on the map of model town for cleanliness. Presently Sri Soundararajan is the PRO of EXNORA at district level. Surely, this is a prelude to our hon'ble Prime Minister's Swacch Bharat Mission.

Sri Soundararajan played an active role in consumer protection activities. He was invited to be the associate editor of the journal *FEDCOT News* issued by the Consumer Protection Council for Tamil Nadu and Pondicherry which he accepted. This work continued for five years.

Succour to tsunami victims

It was during the tsunami that badly devastated the town and 77 villages in the district that Sri Soundararajan unleashed his full potential by helping the victims wholeheartedly. On the morning of 26 December 2004 the tsunami took a heavy toll in Nagore, Nagapattinam and Velankanni on the eastern seaboard owing to its geographical position. About 240 survivors who formed part of Samanthanpettai village were given shelter in the nearby wedding hall and food and clothing were arranged for them immediately by him. They were very well looked after by R Soundararajan until they were provided temporary shelters (read tin-huts). He wrote extensively about his experience during tsunami which was published in Pensioners' Champion (January 2005 issue). His selfless service was very much appreciated by the Rotary International and the district administration. He said he derived immense pleasure by serving the needy. This is an example of how one could extend help to the forlorn with a sound intellectual framework without running away from the scene.

One of his hobbies is stamp collecting. When scientifically done, it is called philately. He started collecting stamps very late in his life and classified them thematically. To encourage young collectors to undertake this hobby he went to schools and colleges and

spoke about the importance of stamp collecting. He also conducted workshops and quiz programmes on the subject. He participated in stamp exhibitions in places like Hong Kong, Chennai, Vadodara and Thanjavur and won accolades.

His other pastime is reading of books, newspapers and periodicals. He has built up a personal library consisting of 1,500 valuable books some of them are rare ones which are out of print. His collection of reference books on various subjects is noteworthy. These are all his "never failing friends"

Sri Soundararajan has a feeling of nostalgia for the accepted social mores in Bangalore where he lived for more than 20 years. Some of them are: inviting friends anytime for a cup of coffee—often 'one by two'—taking sustenance in popular masal dosa, consuming avarekai in the menu like usli and upiittu and enquiring of the neighbours about the quantity of avarekai they bought during the season to score a victory.

Simple living and high thinking has been the credo of Sri Soundararajan. What is more, he has been donating fifty percent of his pension for the autism-affected poor students with the hope that they would one day join the mainstream of the populace, so that his small help would bring sunshine in their life.

Let us pray for his health and long life.

Sultan Ahmed , Dushyant Chautala Will the Minister of Finance be pleased to state:-

- (a) Whether the Government has set up a Committee to examine the various allowances in the light of recommendation made by the Seventh Central Pay Commission;
- (b) If so, the details and terms of reference thereof:
- (c) Whether the said Committee on allowances has submitted its report to the Government, if so, the recommendations made by the Committee along with the follow-up action taken by the Government thereon:
- (d) If not, the reasons there for and the time by which the said report is likely to be submitted;
- (e) whether the Government proposes to give

arrear of House Rent Allowance and other allowances with effect from the month of notification of implementation of Seventh Central Pay Commission, if so, the details thereof and if not, the reasons there for?

ANSWER

Minister of State in the Ministry of Finance

(Shri Arjun Ram Meghwal)

- (a) & (b): Yes. The Committee on Allowances has been constituted vide order dated 22.07.2016. The Committee is to examine the recommendations of the 7th CPC in regard to various allowances having regard to the representations made by the Staff Associations and the suggestions of the concerned Ministries/Departments and make recommendations as to whether any changes in the recommendations of the 7th CPC are warranted and if so, in what form.
- (c) to (e): The Committee has not submitted its report to the Government. The deliberations of the Committee are in the final stages. Decisions on implementing the Report will be taken after the Report is submitted by the Committee.

Legal Matter

1. Grant of upgraded Pay Scales to Income Tax Officers / Income Tax Inspectors w.e.f 1-1-1996

Filing of Income Tax return for the Financial Year 2016-17 (Assessment Year 2017-18)

Every individual has to furnish the return of his income, if his total income before allowing deductions under Chapter VI-A, exceeds the maximum amount which is not chargeable to Income Tax

In the case of a Senior Citizen (age between 60 & 79) filing of Income Tax return is obligatory if his/her total income exceeds Rs.3,00,000 for the financial year 2016-17. Very Senior Citizens (age 80 & above) whose total income for the relevant assessment year does not exceed Rs.5 lakhs are exempted from filing returns from the assessment year 2011-12 subject to certain conditions. However, if their income is above Rs. 5,00,000/- filing of IT return is obligatory.

Rates of Tax payable by Senior Citizens (60 years and above but less than 80 years)

Where the total income does not exceed Rs.3,00,000	Nil

3.	Where the total income exceeds Rs10,00,000	Rs.1,00,000 plus Rs. 30% of the amount by which the income exceeds Rs.10,00,000

Reimbursement of medical claims to pensioners under CS (MA) Rules, 1944 as directed by various CATs/Courts

Gol, MoH & FW No. S.14025/23/2013-MS.EHSS dated 29th Sept 2016

The undersigned is directed to state that various references are being received in Ministry of Health and Family Welfare on the above mentioned subject. It is hereby clarified that CS (MA) Rules, 1944 are not applicable to pensioners as on date.

2. It is further informed that following options to avail medical facilities are available to Central Govt. pensioners

a) Pensioners residing in CGHS covered areas

- They can get themselves registered in CGHS dispensary after making requisite contribution and can avail both OPD and IPD facilities.
- 2) Pensioners residing in CGHS Areas cannot opt out of CGHS and avail any other medical facility (i.e. Fixed Medical Allowance). Such pensioner, if they do not choose to avail CGHS facility by depositing the required contributions, cannot be granted Fixed Medical Allowance in lieu of CGHS

b) Pensioners residing in non-CGHS areas

1) They can avail Fixed Medical Allowance (FMA) @ Rs. 500/- p.m.

CGHS Wellness Centre No. 3 to be shifted to new premises

CGHS Wellness Centre No. 3, Basavanagudi is being shifted to a new premises in Banashankari 3rd stage, near Vinayaka Nursing Home. Shifting may be completed by the end of April-2017. Initially, all the cards of beneficiaries attached to Basavanaudi WC will be transferred. Later on re-allocation of cards between Jayanagar and Basavanagudi WCs will be done. Review of coverage area to bring new areas under CGHS WCs is also likely to be done later.

- 2) They can also avail benefits of CGHS (OPD and IPD) by registering themselves in the nearest CGHS city after making the required subscription
- They also have the option to avail FMA, for OPD treatment and CGHS for IPD treatments after making the required subscription as per CGHS guidelines.
- 3. In view of the above, reimbursement of medical claims to pensioners under CS (MA) Rules, 1944 as directed by various CATs/ Courts need not be referred to the Ministry of Health and Family Welfare. The respective Administrative Department /Ministry may take their decision in this regard.
- 4. Further, all Departments/Ministries are requested to intimate their employees proceeding for retirement regarding the above options for medical facilities available to the Central Government pensioners.
- 5. This issues with the approval of competent authority
