Shri R. Soundararajan, a very senior member, and a philanthropist, fondly known as 'Vaadiyaar', lived alone in Nagapattinam, Tamil Nadu after retiring as the Instructor in Postal Training Centre, Mysuru. He was a well-wisher of our Association, regularly advising us on various matters. It is at his suggestion that the columns 'Our Readers Write' & Question Corner were introduced in our journal. He was indeed a friend, philosopher and guide. He taught Trainees of Railway Mail Service Locally in Bengaluru also. His students all loved him.

Hence his sobriquet 'Vaadiyaar'. After his retirement, he was involved in various social service activities locally. Mild and soft-spoken, he was an intellectual giant. MA in English, he, even in old age, participated in literary contests and won prizes too. His demise is a real loss to our association and the society as well.

Shri K K Gangadharan, retired LSG supervisor, Bengaluru City RMS, was a literature. From his early age, he took interest in translation work, translating many Malayalam works to Kannada. A very friendly creature, he was fondly known to his vast circle of friends as KKG. He was a regular columnist in various Kannada magazines. He had been awarded the annual literary award "the best literary translation work of the year - 2011" by the Government of Karnataka and the 'Kendra Sahitva Academy' award -2023 in the category of translation work. Academy award was presented to him at a function held at Bharathiya Vidya Bhavan on 12-07-2024. He was felicitated by our Association in the annual general body meeting in 2024 for bringing laurels through his literary achievements. His death is a great loss to Kannada literature. Our readers paid tribute to him on his demise.

The Members of the Executive Committee express their heartfelt condolences to the members of the bereaved families.

The E C pays its respectful homage to all the Political Leaders, Trade Union Leaders, and eminent personalities who passed away during the year.

3. Activities

Annual General Body meeting 2024:

A. The 29th Annual General Body meeting of 2024 was held on 3.8.2024 at NGO Hall, Cubbon Park, Bengaluru 560001. Dr. C R Chandrashekar, a renowned psychiatrist and a 'Padmashri' awardee in 2024, was invited as Chief Guest on the occasion. There was a huge crowd of Members in the meeting including

those from outside Bengaluru including Mysuru, Shivamogga Kolara etc. On invitation by the Association, members of other Pensioners Associations, affiliated to CCCGPA, attended the AGB. The auditorium was filled to capacity. The total attendance exceeded 460.

B. The morning session commenced at 9.30 am. Shri K.B.Krishna Rao, Secretary, welcomed the guests and gave a brief introduction of the Chief Guest, which included his numerous achievements, social works, literary works and various awards, conferred on him by the government of Karnataka, Indian Government and many social service organizations. He placed the agenda for adoption and the same was adopted by the house. Agenda included felicitation of Shri K.K.Gangadhara, cash awards to meritorious students, felicitation of members of 75 years and above. As a part of the agenda, the report on the AGB of 2023, draft annual report for 2023-24 and draft annual accounts for 2023-24 were also adopted by the house. The draft annual report and annual accounts for 2023-24 had been published in 'Pensioners' Champion' for June 2024. The Secretary, however, gave a gist of the annual report in his speech.

C. After the names of the expired members were readout, a minute's silence was observed to mourn their deaths and also that of leaders and eminent personalities.

D. In the Open Session, Dr.Chandrashekar gave a speech in Kannada in a unique style. He moved around on the dais, engaged in conversation with the audience and gave practical advice on physical and mental health in old age, including food habits, exercise, regular health checkups etc. The audience was mesmerized by his speech and gave a thunderous applause at the end. He was affable enough to pose for selfiees with members. He was felicitated by the President, Vice President and the Secretary. His 2 works in Kannada and English were made available for sale and all copies were sold out.

- **E.** Shri N.Bhaskaran, founder secretary and permanent Advisor, in his 90s, escorted by his son attended. He was honoured by the President. The late Shri K.K.Gangadharan, a member, was also felicitated for winning a 'Kendra Sahitya Academy' award for translation work.
- **F.** On this occasion, a Postman and a post woman viz., Shri Mohan, Postman of Vidyaranyapura PO and Smt.Amrutha, Post woman of Basaveshwaranagar PO, were also honoured in the tradition that was started in 2022. Another tradition of awarding cash prize of Rs.1000 each, to 20 meritorious students of Government Higher Primary School, Yelahanka and Srirampura, Bengaluru also followed. The Chief Guest, President, Vice President and EC members distributed the awards.
- **G**. The list of members, who attained 75 years born between 1.4.1948 and 31.3.1949, including those who joined as members during the year was published in *'Pensioners' Champion'* of June 2024. They were felicitated by the Chief Guest, President, Vice President, Advisors and EC members by garlanding them, draping the shawl and gifting with the fruit basket.
- H. Then, Shri M.Ramiah and Shri H.S.Manjunatha, Permanent Advisors were honoured by the Association. The following office bearers of the other Pensioners' Associations, who were present in the function, were also honoured.Viz: Shri T.V.Suryaprakash, CBPA, Shri Gangadhara Rao, AIBSNLPWA, Shri P.S.Prasad, President COC-K and Smt. Juliana Vincent, Secretary SIPA.
- I. The Open Session ended with the presidential address and vote of thanks by the Joint Secretary. Lunch was arranged for all.
- j. The Afternoon Session, consisting of Members of the Association, started after lunch at 2.30 pm. The agenda included (a) Constitution of 8th CPC; (b) notional increment to pensioners who retire on 30th June and 31st

- December; (c) Restoration of commutation after 12 years instead of 15 years; (d) Revision of pension of BSNL pensioners from 1.1.2017; (e) CGHS and FMA and (f) any other subject with the permission of the chair.
- **K.** The Secretary requested Shri P.S.Prasad, Jt Secretary, CCCGPA to address the meeting on restoration of commutation earlier than 15 years, as the latter had prepared a comprehensive document on the subject. Shri Prasad dealt at length explaining the excess amount recovered, mortality rate, rate of interest etc. He explained the various court cases filed and their results. He offered to share all the documents collected by him with anyone who is interested.
- L. The Secretary then invited Shri P.Gangadhara Rao, Vice President of CCCGPA to speak on the subject of BSNL pension, saying that Shri Rao is the signatory to the application filed by AIBSNLPWA before the Principal bench of CAT, New Delhi and that, consequently, the right person to speak on the subject. Shri Gangadhara Rao opened his speech, saying that the issue is as old as 2009. The last revision of pension of BSNL pensioners was done from 1-1-2007. But, when 7th CPC was formed in 2013, the issue of BSNL pension was not included in the terms of reference despite the Chairman 7th CPC agreeing that BSNL Pensioners have a genuine demand. Therefore, there was no option but to file a petition in the CAT Principal Bench, New Delhi and he himself is the signatory to it. The PB, CAT allowed the petition and ordered that their pension should be revised in accordance with the Central Pay Commission. But the Government chose to challenge the order by filing a writ petition in the High Court of Delhi. The case is still pending in the H C Delhi.
- **M.** The subject of 8th CPC was taken up. The Secretary mentioned that the next pay commission i.e. 8th CPC is due on 1.1.2026. As the Commission usually takes at least a year to prepare its recommendations, the

Government appoints it in advance. But this time, in spite of demands from Central Government Employees Unions and Pensioners Associations, the Commission is not yet constituted. The Government has even given a reply in the Parliament that there is no proposal to constitute the pay commission. Therefore, Employees and Pensioners have increased the pressure, the apex bodies of both conducting periodical programmes like Dharnas, Parliament Chalo etc. Our Association has participated in all the agitations called for By NCCPA. The President Shri G.Babu said that when the CPC is constituted, we can think of submitting a common memorandum.

An update: The Union government on 16th January, 2025, approved the establishment of the 8th Central Pay Commission accepting demands of NCJCM, NCCPA and Central Employees and Pensioners' organisations in the country.

N. On the subject of notional increment for pensioners retiring on 30th June and 31st December, the Secretary said that KPTPA was the first to take up the issue and even suggested that relevant Rules may be amended accordingly, as has been done many times before and the same suggestion has been adopted by NCCPA when Com K K N Kutty was S G NCCPA. KPTPA gave this as an item for discussion in 33rd SCOVA meeting held on 22.2.2024, which was attended by Smt.N.Nagalakshmi, Vice President. Smt. Nagalakshmi, who was present, said that, during the meeting, the MoS, Ministry of Public Grievances and Pensions asked the Secretary, DOPPW to address the Attorney Generals as it is a matter of amendment of Fundamental Rules. The Secretary gave the latest position; saying that the Supreme Court has dismissed on 11.4.2023 and 19.5.2023 the SLPs filed by the Govt, and on 6-9-2024 pased an order for grant of increment to eligible pensioners for pensionery benefits. DOPT issued an order on 14-10-2024 for implementation of the Supreme Court order. The Association wrote to Shri Vineet Pandey, Director of Posts to intervene and direct CPMG, Karnataka Circle to withdraw the petition pending before the High Court of Karnataka so that the similarly placed pensioners can get the benefit. Shri H.S.Manjunatha, Legal Advisor, suggested that the petitioners may file an application before the High Court through their advocates, praying for the implementation of CAT orders, now that the matter has attained a legal finality after the dismissal of the SLPs by the Supreme Court.

An update: The Hon'ble Supreme Court dismissed the SLPs filed by the Govt. and passed orders on 6-9-2024 and 20-1-2025 directing the Govt. to grant increment to all eligible pensioners for pensionery benefits. In Karnataka Postal Circle, most of the Notional Increment cases have been settled and arrears paid in March, April and May 2025. However, the Association shall pursue the pending cases brought to its notice by the members with the concerned authorities.

O. In the matter of CGHS and FMA, the Secretary said that the CGHS Directorate has issued some recent orders, according to which (a) the referral issued by the CGHS doctor is now valid for 3 months instead of one month; (b) a single referral letter is enough for three consultations with specialists and for two consultations with each specialist; (c) no referral letter is necessary for consultations with specialists in CGHS empanelled hospitals for pensioners aged above 70 years. He said that the Association has been demanding a full-fledged CGHS wellness centre at Sahakaranagara instead of just an extension counter sanctioned. He also said that the sanctioned wellness centre at Hubballi is still to be opened. He hoped that the wellness centres at Mangaluru, Udupi and Shivamogga may also be opened soon as the Govt. has informed in the Lok Sabha that the Govt. has agreed in principal to open CGHS WCs in the 3 Cities. On a query about FMA, he replied that the demand is to enhance it to Rs.3000 from the existing Rs.1000 and that it is reliably learnt that a note in this regard has gone to the Finance Ministry so that orders may be received soon.

- P. Queries were raised by members about other subjects like additional pension after 65 years and issue of ID cards to pensioners. The Secretary replied that the Government has rejected the recommendation of the Parliamentary Standing Committee to pay additional pension every 5 years on the plea of huge financial implications. As for ID card, he and the President also said that already there are many ID cards and pensioner ID card does not seem to be necessary right now.
- **Q.** The President Shri G. Babu gave a speech, in which he expressed happiness over the interest shown by members by turning up in such large numbers and the efficient manner in conducting the AGB. He said the speech of the Chief Guest was unique and educative. He thanked everyone in making the AGB a grand success. Shri V.Murugan, Joint Secretary proposed vote of thanks. AGB ended at 5 pm with rendering of National Anthem "Janaganamana" in chorus.

4. Charitable works

4.1 Charitable function held on 06.02.2024

The function is held every year on 6th February, at Government Higher Primary School, New Town Yelahanka. Sri S.M. Vittal Rao, former Treasurer, in spite of his age and health condition, evinced great interest in arranging the function with the help of the staff of the School. It was attended, along with Shri Vittalrao, by Shri V.Murugan Jt.Secretary, Sri K.R. AnanthaRamu, Treasurer, Shri B Nagaraju, EC member and Shri M.Nanjunda Gowda, former EC member. About 120 students studying in all classes in the school had assembled in the hall. Note books, pens, sweets and fruits were distributed to the students. A big cake was cut and distributed to all students and all others present.

The students presented cultural programmes like group dance, songs and skits. As always, the staff expressed their appreciation in arranging the event and presentation of cash awards to meritorious students in the AGB of KPTPA. Shri Anantharamu, in his speech, said that the Association would endeavour to continue with this avowed objective of encouraging students of government schools. in achieving better academic standards, by giving them cash awards as had been the practice since almost 25 years. Since last year, another Government school at Sriramampura village is also added for the purpose of cash awards. From 2025 onwards the awards will be presented to 30 students of Govt Schools

4.2. Free lunch was served to the cancer patients at Kidwai Memorial Institute of Oncology, Bengaluru on 17.12.2024 from the donation made by the Association to the Institute.

5. Other activities

5.1. Executive Committee Meetings

The Executive Committee of the Association used to meet usually on 2nd Saturday of every month in Pensioners' Bhavan, the Association's own building in Telecom Lay out, off Bengaluru International Airport Road. In 2024 it had been decided to hold online meetings once in three months, as EC members felt that it was more convenient to participate sitting at home. So, alternatively, meetings are held at Pensioners Bhavan, at Hotel Shanthisagar at Basaveshwaranagar and online. In the EC meeting held in April 2024, Shri K B Krishna Rao, Secretary who attained 80 years, was honoured by the President Shri G Babu. He hailed the excellent service made by Shri Rao to KPTPA ever since he joined succeeding Shri N. Bhaskaran as Secretary in 2013. Shri Bhaskaran himself has said many times that Shri Rao is the worthy successor. Shri M Ramiah, Ex Vice-President also complimented Shri Rao on his birthday and hailed his services. He was presented with a garland, shawl and a fruit basket. In May 24, Shri G Babu himself turned 80 and he was also honoured by Shri M Ramiah, former Vice-President. Both Shri Ramiah and Shri Krishna Rao recalled Shri Babu's role in granting a big site to the Association in Telecom layout and also his help afterwards in constructing Pensioners Bhavan there. He was also gifted with fruit basket, shawl and garland. It was decided to honour EC members, both present and erstwhile, on attaining the ripe age of 80/90 years.

5.2. Demonstration by Pensioners.

Demonstration was held at Freedom Park, Bengaluru on 4.4.2025 in response to the call given by NCCPA to hold demonstrations to oppose "Validation of CCS (Pension) Rules and Principles for Expenditure on pension liabilities. CCCGPA-Karnataka organised the Demonstration. Many Pensioners Associations, affiliates of CCCGPA Karnataka, and a few more, participated in the demonstration which was well attended by about 500 pensioners. All the arrangements for holding the demonstration were made by Com G Babu, AGS, AIBSNLPWA & President, KP&TPA assisted by T.V.Survaprakash, Secretary, Coffee Board PA & Com K Nagesh ECM, KP&TPA.

Com K B Krishna Rao, President, CCCGPA Karnataka, Com S.Radhakrishna, General Secretary, CCCGPA, Com P.Gangadhara Rao and Changappa of AIBSNLPWA, Com Muddaiah, Secretary AIBDPA, Com Girish Kanagotagi, President. KCGPA, Com B.V.Venkatesh, Secretary, Karnataka Income Tax Pensioners Association Com T.V.Suryaprakash, Secretary, Coffee Board PA, Com P S Prasad, Ground Water Board PA, Com Juliana Vincent, Secretary Survey of India Pen Assn., Com B.R.Venkatesha Murthy, Kendriya Vidyalaya Sanghatan Retd. Employees Association &

Com A Srinivasa Vice- President, COC Karnataka & Permanent invitee NFPE and other representatives of Pensioners Associations addressed the gathering.

5.3 Pensioners' Day: Celebration of Pensioners Day and successful completion of Digital Life Certificate Camps

(a) Pensioners' Day' was observed by the association in association with the Coordination Committee of Central Government Pensioners' Associations, Karnataka (CCCGPA) and its affiliate Pensioners' Associations, on 17th December, 2024 V.A.N. Namboodiri, the veteran P&T Trade Union Leader and Leader of the Pensioners movement in the country was the Chief Guest.

Sri Krishna Rao, in his opening remarks said that Com V.A.N. Namboodiri, who had addressed CCCGPA pensioners in 2020 through a video conference, is physically present and will be addressing the pensioners. He said that the day is to be marked as a Red-letter day in the annals of the history of CCCGPA-K.

Sri S.Radhakrishna, GS CCCGPA welcomed the Chief Guest, Sri G.Babu, President KP&TPA and all others present and introduced Com Namboodiri, as one of the great leaders of the working class movement in the country, who has been in the fore front of all the struggles of the central employees and pensioners and requested him to address the pensioners who had assembled in a very good number.

Comrade V.A.N.Namboodiri, Veteran P&T Trade Union Leader, Founder General Secretary BSNLEU, Advisor AIBDPA, Patron NCCPA and a Veteran Leader of Pensioner Community, in his hour long address spoke about many issues concerning pensioners and the working class. (His speech was published in Pensioners' Champion-August 2024 issue).

Sri G. Babu, President KPTPA, a veteran leader of the BSNL employees & Central Pensioners in Karnataka, in his brief speech,

mentioned about the issues facing the pensioners and the role played by the pensioners associations, especially CCGPA and K PT PA.Com Namboodiri was honoured by CCCGPA-K & KP&TPA

(b) Presentation of a report on Successful completion of Digital Life Certificate Camps organised by Karnataka P&T Pensioners Association and Coffee Board Pensioners Association

Sri K.B.Krishna Rao, Secretary, KP&TPA furnishing details, said that 33 Volunteers had generated 3530 Digital Life Certificates in October & November 2024 in 39 camps, 27 in Bengaluru and 11 in the other cities of Karnataka and 1 in Thirupathi. The Volunteers, he said, visited 1438 residences of aged pensioners and Old age homes and generated their life certificates from the comforts of their homes. He said that Sri T V Survaprakash, Secretary Coffee Board Pensioners Association was the "brains behind" the successful DLC campaign 2024, who planned and organised many camps. He was ably assisted by S/s K.R.Anantha Ramu, B.Nagaraju, Viswanatha Rao, K Nagesh, A Prakash and many others.

Sri K.B Krishna Rao said that he was extremely happy to note that each year more volunteers start generating DLCs, totally 33 volunteers in 2024 including those from out of Bengaluru. Many members of the associations from Mysuru, Nanjanagudu, Chamarajanagara, Thumakuru, Hassan, Davanagere, Chitradurga, Shivamogga, Chikkamagaluru, Kolara and Robertsonpet evinced keen interest in organising DLC camps in which a good number of pensioners submitted their annual life certificate.

S/S.Rajashekhara, Mysuru, V.Shashidhara, Shivamogga, B.T.Chandrasekhara Davanagere, H.S.Rajendra, Chikkamagaluru, H.R. Suresh, Kolara, K. Anand, Dundamadaiah, Chamarajanagara and many others had made the arrangements for conduct of DLC Camps.

Sri Rao, profusely thanked all the volunteers, for their selfless service and extended grateful thanks to all those who were responsible for successful conduct of DLC camps. He said that the number of DLCs generated in 2024 is a record and KPTPA& CBPA top the list of DLCs generated by Pensioners Associations in the country.

5.4. Swachha Bharat Abhiyan / Cleanliness Drive

In compliance of the desire expressed by the Department of Pension and Pensioners Welfare, New Delhi that the Association participate in the "Swachhta Pakhwada" by holding cleanliness drive on 1st October 2024, Karnataka P&T Pensioners' Association, in coordination with the Pensioners' Associations affiliated to the CCCGPA-K conducted cleanliness drive in the 1st Main Road and 11th Cross of Telecom Layout, off Bengaluru International Airport Road, Sriramapura, Bengaluru 560064 near the Association's own building "Pensioners Bhavan". About 40 Pensioners from the affiliates of CCGPA actively participated in the drive and cleaned the surroundings of Pensioners Bhavan in the 1st Main Road and 11th Cross of Telecom Layout which were selected for cleaning purposes. The Roads were cleanly swept and the trash disposed of. The drive lasted for about 2 hours.

5.5. World Pensioners day 1-10-2024

The Coordination Committee of Central Government Pensioners Association Karnataka (CCCGPA-K) with its affiliates (1) Karnataka Posts and Telecommunications Pensioners Association, (2) IA&AD Pensioners Association, (3) Coffee Board Pensioners Association and (4) Survey of India Pensioners Association, Bengaluru observed "International Day of Pensioners and Retirees - World Pensioners Day" on 1-10-2024 at "Pensioners Bhavan", Telecom Layout, Bengaluru in response to the call given by the National Coordination Committee of pensioners Association (NCCPA). About 35 pensioners

from the above Associations were present. Sri K B Krishna Rao, Secretary KP&TPA who is also the President CCCGPA presided. Sri S Radhakrishna, General Secretary, CCCGPA spoke about the importance of the Day. Com Juliana R Vincent, Secretary, Survey of India Pensioners Association also addressed the gathering.

Sri T.V.Suryaprakash, Secretary, Coffee Board Pensioners Association & Jt.Genl Secretary, CCCGPA coordinated with all the Pensioners Associations.

Sri Krishna Rao while welcoming the gathering spoke briefly about the significance of International Pensioners Day on 1st of October and requested Sri S.Radhakrishna, G S, CCCGPA to enlighten the audience about the importance of World Pensioners' Day on 1st October.

Sri Radhakrishna, while speaking on the subject mentioned that 1st October is being celebrated as International Elders' Day. He mentioned that according to a survey, by the year 2030, the seniors attaining age of 70 years will exceed the population of people aged below 70 years. To help senior Citizens to lead a better life. like minded Pensioners Associations &Trade Unions have raised some demands and they are (1) Decent pension to all (2) Decent health and medical care (3) Decent accommodation (4) Free transport (5) Potable water (6) Non-contributory Pension. He said that the international Pensioners day is being celebrated since four years. Last year, the conference was held at Athens (Greece) and from India Com K Ragavendran and 3 others represented India. He concluded by saying that the above mentioned demands will be pursued strongly till justice is done.

Ms Juliana Vincent, Secretary, Survey of India Pensioners Association suggested that some type of a plan may be worked out to get some additional amount to pensioners considering the present day economic conditions. She opined that Unified Pension

Scheme (UPS) recently announced by the Government may not be helpful and we have to demand OPS to all.

Sri M.Ramakrishna said that he learnt that many officials now covered by NPS are not willing to opt for UPS. Hence some kind of orientation programme may be conducted to educate them.

6. Our Members: their Laurels ANUBHAV AWARDS, 2025

6.1. The Association is delighted to note that one more member of our association, Sri. O. Virupakshappa, L.M. 3408, former Senior Superintendent of Post Offices, Dharwad Division has been selected for the prestigious "Anubhav Award 2025" by the Department of Pension and Pensioners Welfare. The award will be presented to him on 18.08.2025 by Dr Jitendra Singh, Hon'ble Minister of State, Ministry of Public Grievances and Pensions.

Sri Virupakshappa is one of the 5 selected for the Award. His write-up, was selected for the Award out of 1459 write-ups received by the Department of Pension and Pensioners Welfare from 42 Departments of Govt. of India.

The other 2 members of our association who were conferred with the Award are (1) Smt.N.Nagalaksmi, Retd. Assistant Chief Accounts Officer, Postal Accounts and Finance, who is the Vice President of KP&TPA.

(2) Sri P. Damodhara Bhat, retired Senior Superintendent, RMS Bengaluru Sorting Division.

In total, 3 members of our Association have been conferred with the Award so far, which perhaps, is a record. The Association is proud of all the 3 members who have brought Laurels to the Association.

recognition of his service to the community, his fight against discrimination of employees at work place, his services for the cause of welfare of his fellow employees while in service & also in recognition of his meritorious service in the Department of Posts.

6.3. The late K K Gandharan(KKG) was selected for the prestigious" Sahitya Academy prize for translation of works of Malayam writers to Kannada. The Academy award was presented to him by the President of Kendra Sahitya Academy in a glittering function held at Bharatiya Vidya Bhavan, Bengaluru on 12-07-2024

7. SCOVA

It is with great pleasure that we announce the inclusion of KPTPA in the Standing Committee of Voluntary Agencies (SCOVA) for the term 2023-2025, that is likely to be extended for another 2 years. This is the third time that DoPPW has recognized our association and nominated to SCOVA. Previously, we were in SCOVA in 2005, 2006, 2007, 2008 (first term) and again in 2013, 2014, 2015, 2016 and 2017 (second term). We thank the Department of Pension and PW for recognizing and giving us an opportunity again to represent the Pensioners Associations of Karnataka at the national level.

Our association, as before, notified many subjects for inclusion in the Agend of SCOVA meetings. Smt. N.Nagalakshmi, Vice President of the Association attended the 33rd meeting of SCOVA held on 22.2.204 and Sri K R Anantha Ramu, Treasurer, attended the 34th meeting held on 11-03-2025. The items given by KPTPA for discussion in the meetings and the Minutes of the meetings have also been published in our journal.

8. Pensioners' Welfare Activities

The association pursued the following issues with the authorities concerned

- a. Grant of Notional Increment to pensioners who have retired on 30th June / 31st December with requisite service for grant of increment
- b. Restoration of Commuted portion of pension after 12 years instead of the existing 15 years.
- c. Inclusion of the item regarding revision of pension of BSNL pensioners in the terms of reference of the 8th CPC.
- d. Consideration of the entire service rendered by Temporary Status Casual labourers (TSCL)after being treated at par with regular group employees for retirement benefits.
- e. Drawal of arrears of pension to pensioners who have retired 30th June/ 31st December who were granted increment for pensionery benefits in accordance with DOPT OM dated 14-10-2024 & 21-05-2025
- f. Conducting Digital Life Certificate camps in Bengaluru and other cities of Karnataka in which more than 3400 pensioners were assisted to submit their annual life certificates
- g. Helping infirm and aged pensioners to submit their life certificate from the confines of their homes.
- h. Writing to the Department of Posts to update the soft ware to facilitate payment of arrears of D R within a reasonable time after issuance of the OM by the Department of Pension &PW instead of at end of the month.
- Assisting pensioners in drafting of their Grievances to the Pension Adalat.
- j. Conversion of single P O SB account into joint account. Postal Directorate has responded positively and has referred the matter to DoE, MoF.
- k. Assistance to all Central Govt.pensioners for submission of their life certificate in October / November, 2024 - Yeomen service by 33 volunteers
- SMS alerts on pension credit to Postal Pensioners
- m. Assiting pensioners in submitting applications for new CGHS Card

9. Long pending Demands

- (a) Release of DA/ DR frozen for 18 months from 1-1-2020 to 30-6-2021
- (b) Restoration of Commutation after 12 years
- (c) Enhancement of Fixed Medical Allowance (FMA) from Rs.1000 to Rs.3000
- (d) Commencement of age-related additional pension at the age of 65 years instead of at 80 years.
- (e) Grant of Financial upgradation under MACP from 1-9-2008 instead of from 1-1-2006
- (f) Financial Upgradation under MACP Scheme (MACP-III) to Promotees in Dept. of Posts

10. Grievances of Pensioners

Grievances of some of our members were taken up with the authorities concerned and some grievances were also registered on CEPENGRAMS of the Department of Pension and Pensioners Welfare. All grievances, except one, were settled to the satisfaction of the pensioners/family pensioners. We are happy to note that members always appreciate our efforts and some of them have even donated to the building fund as a token of their gratitude.

11.CGHS Matters

- (a) Opening of a full-fledge CGHS WC in Hubballi instead of the extension counter sanctioned a year ago, which also, is yet to be opened.
- (b) Opening of CGHS WCs in Mangaluru, Udupi and Shivamogga

This issue also is being pursued by the association since many years. There is justification for opening CGHS WCs in all the 3 cities. We had also furnished the required statistical data to the AD CGHS. We are glad that the Health Ministry has agreed in principle to open CGHS WCs in all the 3 cities, along with 19 other WCs in the country as revealed by the Minister of State, in the Ministry of Health & Family Welfare in the Parliament on 2-8-2024 in reply to a question raised by Sri B.Y.Raghavendra, M P Shivamogga.

We have been pursuing the issue regarding opening of more CGHS WCs in Bengaluru city and opening of a Full-fledged WC at Shakaranagar, Bengaluru.

(c) Revision of CGHS Package rates

This issue was being pursued strongly with CGHS/ MOH&FW by CCCGPA and many Pensioners' Association in the country for years. Finally, package rates of OPD consultation, Ward charges, ICU charges, 36 Radiological & Imaging investigations etc., were revised. We have also demanded Revision of Ward entitlement for those CGHS beneficiaries who retired on or after 01.01.2016

12. Our role in connection with Pensioners' Portal & our relationship with DOPPW

KP&TPA is one of the 4 associations in Karnataka identified by DoPPW under National e-Governance Plan (NeGP). The association gets an annual grant of Rs.75,000/-. Sri V. Srinivas, IAS, Secretary, DOPPW in the last virtual meeting informed Pensioner' Associations that the Grant-in-Aid will be increased to Rs.5,00,000 p.a. from the year 2025-2026.

We have been maintaining a cordial relationship with the Department of Pension and Pensioners' Welfare. Under the initiative of Shri V Srinivas, IAS, Secretary, Department of Pension and Pensioners' Welfare, virtual meetings are being held frequently. Our association has been attending all the meetings and bringing to the notice of the Secretary issues that required to be brought his notice.

13. Our Website

The Association has its own website www.kptpa.org. It has been maintained for the last 14 years now. The journal *Pensioners' Champion* and other important orders are being uploaded every month. List of donations for the building fund received up to 31-3-2025 has

been uploaded. We request our members to visit the site regularly and suggest improvements.

14.WhatsApp groups

WhatsApp groups viz. kptpa, KP&T Pen Asssn-Gp 1 and Gp 2, have been created to which the monthly journal and other orders are being regularly posted. Information on pensioners' welfare/CGHS is also being posted in the groups. At present, there are 1005 members in these 3 groups. We are making efforts to include the mobile phone numbers of all members who have android mobile phones. We request other members also to join the group by sending a WhatsApp message to our EC members Sri K Nagesh: 9448705268 or to Sri Viswanatha Rao: 9343518849.

15. Our Publication- Pensioners' Champion:

15.1 The Association's monthly journal titled Pensioners' Champion is also very popular. Matters relating to central government pensioners find a place there, like the government orders on pension, DR etc., report on SCOVA / JCM meetings, court orders on pension, report on the activities of sister pensioners' associations, health tips etc. Besides, information about Autonomous body pensioners, BSNL, CGHS, Obituaries and the feedback from readers in the column 'Our Readers Write', list of holidays and Consumer Price Index are some of the regular columns. A new column "Question Corner" has been introduced from January 2023 to provide a facility to our readers to write to us on issues regarding pension, family pension and other pension related issues on which they need some information/clarification.

Names of the new members, lists of renewal of subscription and donation received for the building funds are integral parts of the journal. About 1800 copies are mailed, which includes about 180 non-member subscribers.

Many Pensioners from other states have also been subscribing for the journal regularly for years. The individual achievements of the members in areas like literature, social service are also reflected in the journal from time to time

15.2. Subscription for the journal and its renewal

Annual subscription for the journal (July to June) is Rs.180/- in respect of members and from Rs.240/-in respect of subscribers to the journal. We find that many of our members have not renewed their subscription for many years. Still, we continued to send them the journal. We are spending a huge amount monthly on printing and posting of the journal due to the revision of printing charges. The rents from it, the interest from the fixed deposits and liberal donations have enabled the Association to manage its financial position. We are glad to say that members are continuing to donate for the building fund. It is heartening to note that 15 of our members have donated Rs.1,00,000 & two of them above Rs.2.00.000 and above to the building fund. Pensioners Bhavan, as per the original plan, must have been built in 2 floors. But due to paucity of funds, the new building could be built with only one floor. Founder of the Association Sri N Bhaskaran, is often reminding our President Sri G Babu to construct a big meeting hall on the 2nd floor. We need funds to go ahead with the construction. Hence we appeal to our members, especially those members who have not contributed to the Building fund so far to donate liberally

Constitution of Legal Fund to meet the expenditure for filing a writ petition before the Hon'ble Supreme Court against "Validation of Pension Rules" passed in the Parliament on 29-03-2025 as a part of the Finance Bill 2025

The National Coordination Committee of Pensioners Association(NCCPA) in coordination with the Forum of Civil Pensioners, in its virtual meeting held on 09-06-2025, attended by many Pensioners Associations in the country, including Karnataka P&T Pensioners Association and some Federations of Pensioners Associations, unanimously decided to file a writ petition before the Hon'ble Supreme Court challenging the validity of the "validation of CCS(Pension) Rules 1972&2021 and EOP Rules 2023 passed in the Parliament on 29-3-2025 as a part of the Finance Bill 2025.

After a detailed, discussion it was decided to contact, Sri Kapil Sibal, the Senior Supreme Court Advocate and an expert in constitutional matters, requesting him to file a writ petition against the said bill passed by the parliament.

The NCCPA has estimated that the expenditure on this score would be about

Rs. 50,00,000 (Fifty lakhs) and has appealed to all its affiliate organisations to donate liberally to the LEGAL FUND.

KP&TPA has been requested to remit at least Rs.1,00,000 (One lakh) to the Legal Fund of NCCPA at an early date to facilitate filing of Writ Petition.

Therefore, we appeal to all of our members to generously donate to the legal fund-NCCPA as the issue is concerning the welfare of ALL CENTRAL PENSIONERS.

We request our members to donate at least Rs.1,000/- (Rs. One thousand) or a higher amount at the convenience of the members to the legal fund.

Revised instructions for the issue of generic/ branded medicines at CGHS Wellness Centres

In continuation of this Ministry's OM of even no. dated 15.01.2018, the instructions for the issue of generic/branded medicines at CGHS Wellness Centres, is as follows:

The medicines prescribed by specialists shall be supplied by CGHS as per the available generic name at the CGHS Wellness Centre. In case the medicine prescribed by the Specialist is available by an alternative brand name having the same composition, it shall be supplied by the brand name available at CGHS Wellness Centre.

If, the medicine prescribed by the Specialist is not available at CGHS Wellness Centre either by generic name or alternate brand name, it shall be indented by the same brand name through Authorized Local Chemist.

2. In view of the above, the CGHS Wellness Centres are directed to strictly adhere to these guidelines to ensure uninterrupted and efficient service delivery to beneficiaries, subject to the admissibility instructions for medicines issued from time to time by the directorate.
