#### 8th CENTRAL PAY COMMISSION CONSTITUTED

Resolution F.No. 01-01-2025-E.III(A) 3rd November, 2025

#### **Gazette Notification**

The Government of India have decided to appoint the Eighth Central Pay Commission comprising of the following:-

- 1. Chairperson
- Smt. Justice Ranjana Prakash Desai
- 2. Member (*Part-Time*) Prof. Pulak Ghosh 3. Member-Secretary - Shri Pankaj Jain

### 2. The terms of reference of the Commission will be as follows:-

- a) To examine and recommend changes that are desirable and feasible in the emoluments including pay, allowances, and other facilities/ benefits, in cash or kind, having regard to rationalization, contemporary functional requirements and the specialized needs of various Departments, agencies and services in respect of following categories of employees:
- (i) Central Government employees industrial and non-industrial (ii) Personnel belonging to the All India Services (iii) Personnel belonging to the Defence Forces (iv) Personnel of the Union Territories (v) Officers and employees of the Indian Audit and Accounts Department (vi) Members of the regulatory bodies (excluding the RBI) set up under the Acts of Parliament; (vii) Officers and employees of the Supreme Court; (viii) Officers and employees of the High Courts whose expenditure is borne by the Union Territories; and (ix) Judicial officers of the subordinate courts in the Union Territories.

[Note: In respect of judicial officers, the Commission shall adhere to the principle enunciated by the Supreme Court in its Judgement dated 24th August, 1993 in All India Judges' Association and Others V/s Union of India and Others, viz. that there shall be no link between service conditions of judges and

administrative executive and that the service conditions of judges have to meet the special needs of the judiciary].

- (b) To work out an emolument structure conducive to attracting talent to Government service, promoting efficiency, accountability and responsibility in the work culture.
- (c) To examine the existing schemes of bonus with a view to improving performance and productivity and make recommendations on the general principles, financial parameters, productivity and performance linked parameters for an appropriate incentive Scheme to reward excellence in productivity and performance.
- (d) To review the existing allowances and conditions of their admissibility and recommend their rationalization keeping in view the multiplicity of allowances.
- (e) (i) To review the Death-cum-Retirement Gratuity of employees borne on the National Pension System (including Unified Pension Scheme) and make recommendations thereon.
  - (ii) To review the Death-cum-Retirement Gratuity and pensions of employees not borne on the National Pension System (including Unified Pension Scheme) and make recommendations thereon keeping in view Para f (iii) below
- (f) To make recommendations on the above, keeping in view:
  - (i) The economic conditions in the country and the need for fiscal prudence
  - (ii) The need to ensure that adequate resources are available for developmental expenditure and welfare measures;
  - (iii) The unfunded cost of non-contributory pension schemes

- (iv) The likely impact of the recommendations on the finances of the State Governments which usually adopt the recommendations with some modifications; and
- (v) The prevailing emolument structure, benefits and working conditions available to employees of Central Public Sector Undertakings and private sector.
- 3. The Commission will devise its own procedure and may appoint such Advisors, Institutional Consultants and Experts, as it may consider necessary for any particular purpose. It may call for such information and take such evidence, as it may consider necessary. Ministries and Departments of Government of India shall furnish such
- information and documents and other assistance as may be required by the Commission. The Government of India trusts that State Governments, Service Associations and others concerned will extend to the Commission their fullest cooperation and assistance.
- 4. The Commission will have its headquarters in Delhi.
- 5. The Commission will make its recommendations within 18 months of the date of its constitution. It may consider, if necessary, sending interim reports on any of the matters as and when the recommendations are finalized

### LIFE CERTIFICATE CAMPAIGN-2025 Assisting Pensioners to submit their Annual Life Certificate

In yet another record- breaking joint performance by Karnataka P&T Pensioners' Association and Coffee Board Pensioners' Association, Bengaluru, improving upon their last year's joint performance in helping pensioners to register their annual life certificates with the Pension Disbursing Authorities - Banks and Post Offices- for continued payment of their pension, the 2 Pensioners' Associations, both affiliates of CCCGPA, Karnataka, during the month of November 2025, organised 53 Digital Life Certificate Camps - 36 in Bengaluru City in various localities and 17 in other cities/towns of the state viz. Mysuru(2 Camps), Thumakuru, Hassan, Shivamogga, Chikkamagaluru, Davanagere, Chitradurga, Kolar, Robertsonpet, Bangarapet, Mulabagilu, Nanjanagudu, Chamarajanagara, Virajapet, Ponnampet, and Tirupathy in AP state.

Some other Pensioners' Associations, viz., Karnataka IA&AD Pensioners' Association, DRDO Pensioners' Association, Karnataka Central Government Pensioners' Association, Central Government Pensioners' Association, Central Government Pensioners' Association, Mysuru, Chikkamagaluru P&T Pensioners Association - all affiliates of CCCGPA-Karnataka, Karnataka Postal Accounts Pensioners' Association and Shivamogga Postal Pensioners' Association joined the venture, which helped in boosting up the number of Digital Life Certificates generated by the volunteers during the year 2025 in comparison with the number for the year 2024.

The Schedule of DLC camps to be organised in November 2025, was drawn up well in advance in September 25 by Sri T. V. Suryaprakash, Secretary, Coffee Board Pensioners Association & Jt.GS, CCCGPA, assisted by S/s K R Anantha Ramu, B.Nagaraju, V. Murugan, Viswanatha Rao,& K. Nagesh and circulated by publishing the

schedule in the Journals.

A record number of 92 volunteers/ coordinators extended their selfless yeomen services to the pensioner community by generating 2487 life certificates in Camps and 1226 life certificates during visits to the residences of the aged pensioners who were unable to attend the camps. Totally, a record number of 3713 Digital life certificates were generated till 21st November, 2025.

The number of volunteers increased from 13 in the year 2022 to 92 in 2025. They were well supported by the Office bearers and members of Residents Welfare Associations, Senior Citizens Forums, Old age homes and of course their friends and acquaintances. The hosts provided the required infrastructure needed for a successful conduct of the camps.

The Hospitality extended to the volunteers by the Coordinators is noteworthy. It is heartening to record that the Officers of the Department of Posts-the Superintendents and the Head Postmasters extended their helping hand to the associations in holding the DLC camps in the premises of the Head Post Offices.

The volunteers visited residences of 1226 aged pensioners, some of whom were bedridden, some using a wheelchair for their mobility, and a few living with oxygen concentrators.

There was a good response from pensioners retired from many Departments of Govt of India, including Defence, Railways, BSNL, EPF, Autonomous Bodies, Banks and State Governments who attended in large numbers in the DLC camps organised by the Associations. In the year 2025, until 21st November 2025, a record number of 3700 DLCs were generated by making use of the fast and hassle free "Face Authentication Technology"

launched by the Govt of India, Department of Pension and Pensioners Welfare in collaboration with The Unique Identification Authority of India (UIDAI) & Ministry of Electronics and Information Technology (Miety).

It is heartening to note that the initial glitches in digital system that were encountered by the volunteers while generating DLCs which were brought to the notice of the Department of Pension & PW, were resolved by the Technical Team which was closely monitoring the process. Personal intervention of Sri V.Srinivas, IAS, Secretary, DOPPW to resolve technical issues was highly enscouraging.

The endeavour of the affiliate Pensioners Associations of CCCGPA-K, in helping all pensioners to submit their annual life certificate FREE OF CHARGES will continue in the months to come.

Apart from generating life certificates of thousands of pensioners in the camps, the volunteers trained a few interested pensioners in downloading the 2 Apps viz. Jeevan pramaan and Aadhaar Face Rd on their mobile phones needed for generating Digital Life Certificates.

SOP for DLC registration was also made

available to such willing pensioners. We are glad to record that some pensioners in Bengaluru, Mysuru, Shivamogga, Chikkamagaluru and other cities have, in right earnest, started helping pensioners to submit their life certificates from the confines of their homes.

We are deeply indebted to the volunteers who, during the earlier part of the year and in months of October 2025 and November 2025, visited homes of thousands of aged pensioners to provide doorstep service.

The volunteers travelled far and wide spending their own money, did not mind the stress and strain involved either in travelling to far off places or commuting to many wards of the City. On some days they were on the job throughout the day. Generating about 4000 life certificates would not have been possible but for their strenuous efforts. It was, undoubtedly, a real team effort in which each and every one of the volunteers contributed his might to the success of the Associations' strivings for helping the pensioners in general and specially those who are old and infirm in particular.

## Protests against "Validation of Pension Rules" An update

### Writ petition admitted by the Hon'ble Supreme Court

The Writ Petition challenging the constitutional validity of "validation of Pension Rules" was filed in the Hon'ble Supreme Court on 16-10-2025 by the National Coordination Committee Pensioners Associations (NCCPA) and 18 Pensioners Associations in the country, including Karnataka Posts and Telecommunications Pensioners Association who are the petitioners.

The petition is filed under Article 32 of the

Constitution by the Advocate Sri Mudit Gupta for the Petitioners was admitted on 17-11-2025. Writ Petition (Civil) 1057/2025 was called for hearing on 17th and upon hearing the counsel, the court ordered issue of notice.

It is hoped that the Hon'ble Supreme Court will grant the prayer of the petitioners for declaring the "validation of CCS (Pension)Rules introduced in Part IV of the Finance Act 2025, as Ultra Vires the Constitution and unconstitutional.

# Revision of Industrial Dearness Allowance (IDA) Rates for Executives holding Board level and below Board level posts and Non-Unionized Supervisors of CPSEs - Effective from 01.10.2025

The undersigned is directed to convey the revised rates of Industrial Dearness Allowance (IDA) applicable to executives holding Board level and below Board level posts and Non-Unionized Supervisors of Central Public Sector Enterprises (CPSEs) following the 1987, 1992, 1997, 2007, and 2017 payscales, effective from 01.10.2025.

The payment on account of dearness allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.

4. The rates of DA payable to the executives holding Board level and below Board level posts and non-unionized supervisors of

CPSEs following 1997, 2007 & 2017 Pay Scales from 01.10.2025 are as under:

2017	51.8%
