Proceedings of the Silver Jubilee Celebrations and Annual General Body Meeting of the Co-ordination Committee of Central Government Pensioners' Associations, Karnataka (CCCGPA) held at Cauvery Hall, Central Revenue Building, Queens Road, Bengaluru 560001 on 02.08.2023

The meeting commenced at 11A.M. Sri K.B. Krishna Rao, President, CCCGPA, Karnataka presided over the meeting and Com. K. Ragavendran, Secretary General, National Co-ordination Committee of Pensioners Associations (NCCPA), New Delhi was the Chief Guest.

Sri S. Radhakrishna, General Secretary, delivered the welcome address. He recalled that the CCCGPA, which was formed in the year 1998 with 11 affiliates, has successfully completed 25 years with 31 affiliates as on date. He highlighted the leading role played by the CCCGPA. Karnataka in the All India Pensioners movement. He welcomed Comrade K. Ragavendran, Secretary General of National Coordination Committee of Pensioners' Associations, New Delhi, who had kindly consented to be the Chief Guest on the occasion of Silver Jubilee Celebrations. He welcomed representatives of the affiliate associations from Bengaluru and from other parts of Karnataka who were present.

Sri K.B.Krishna Rao, in his introductory remarks, spoke about the leadership qualities of the Chief Guest Com.K.Ragavendran. He mentioned that Com.Ragavendran led the National Federation of Postal Employees (NFPE) while in service and has taken over as Secretary General NCCPA, New Delhi after the sudden demise of Com.K.K.N.Kutty in December, 2022. He was Working President of Confederation of Central Govt. Employees and Workers and General Secretary of AIPRPA. He is the present President of AIPRPA. Member of the Technical & Research Commission of Trade Union International (Pensioners and Retirees) and Asia Continent Coordinator of TUI.

Before going ahead with the agenda,

Sri Radhakrishna paid rich tributes to the former Secretary General of NCCPA, the Late Com. K K N Kutty who expired in December, 2022. The House expressed condolences to the departed souls during the period under report and observed a minute's silence in their honour.

Thereafter, Com.K.Ragavendran inaugurated the Silver Jubilee Celebrations. In his inaugural address, he spoke at length about the various demands of the pensioners. He said that pension updation and medical benefits are the main demands of the pensioners. He mentioned that the Pay Commissions take care of the pension updation of Central Government pensioners. He thanked the Confederation of CG Employees and NC JCM for their role in timely updation of pension. He emphasized the need for establishing rapport with the service organizations to achieve the demands of pensioners. With regard to medical benefits, the Chief Guest remarked that problems of CGHS are being taken up by the NCCPA and the demand was to open CGHS Wellness Centres in every district and to empanel at least one hospital in every district. While discussing the issue of parity in pension, he equated the demand for pension parity to the One Rank One Pension demand of the defence personnel and said that the pensioners are forced to seek legal remedy to achieve their just demand. On the issue of DA/DR arrears for 18 months, he stressed the need to continue the fight since the Government has not accepted the demand. With regard to the New Pension Scheme, he urged the pensioners associations to support the serving employees though the issue does not concern pensioners. He spoke on MACP anomalies, rejection of Parliamentary Standing Committee recommendations by the Government and denial of Railway concession to senior citizens. With

regard to Notional increment for retirement benefits to pensioners who retired/retire on 30th June/31st December after serving for a year after their last increment, consequent to the Order of the Hon'ble Supreme Court on 19.5.2023, the issue seems to have attained legal finality and the Government is expected to issue a general order extending the benefits to the similarly placed pensioners.

Regarding Fixed Medical Allowance he said that the Parliamentary Standing Committee on Personnel, Public Grievances, Law and Justice, in its 120th Report has recommended to the Department of Pension and Pensioners Welfare to take up the issue of enhancement of Fixed Medical Allowance from Rs.1000/- to Rs.3000/- as Rs.1000 is a very meagre amount for an old age pensioner and this recommendation is under active consideration of the Finance Ministry.

Com. Ragavendran also referred to the rally at Jantar Mantar, which was organised by the NCCPA on 21st July 2023 and said that despite shifting of the venue of the rally by Delhi Police at the last minute it was successful. More than 2500 pensioners coming from all parts of the country participated in the Rally. At the end of the Rally, Memorandum with annexure having tens of thousands of signatures of pensioners obtained on the 15 Points Charter of Demands was submitted to the office of the Prime Minister by him and Com V.A.N. Namboodiri who were escorted by the Delhi Police in their van from Jantar Mantar venue to the Prime Minister's office where the designated official accepted the memorandum on behalf of the Prime Minister.

He also reiterated the need for unity among the various pensioners associations to achieve the pending demands. Citing the findings of American research studies that 60 to 80 years of age are the productive years of a man, he urged the pensioners to unite and voice their demands militantly. At this juncture, he also referred to his recent request to the Bharat Pensioners Samaj and other Pensioners' Associations in the Country to unite together to present a common Memorandum to the 8th CPC as and when it is constituted. He concluded his address by wishing the Silver Jubilee Celebration a grand success.

On the occasion of the Silver Jubilee Celebration of CCCGPA, Karnataka, Sri Radhakrishna read out the messages of Sri Shiv Gopal Mishra, Secretary, Staff side N C JCM and S.S. Ramanatha Rao, former President, CCCGPA, Karnataka.

Com. K.Ragavendran, thereafter, released the souvenir brought out on the occasion.

Sri Krishna Rao mentioned that the souvenir traces the entire history of the CCCGPA, Karnataka right from its inception in 1998 and spoke about the role of Sri N Bhaskaran and Sri B Sadashiva Rao who were the forces behind the formation of CCCGPA. He briefly read out the contents of the souvenir and sought feedback of members. Sri Radhakrishna shared his involvement with the CCCGPA along with Sri G. Babu even before retirement.

The agenda of the AGM was taken up for discussion thereafter.

Agenda Item No.1: Honouring of founders and ex-office bearers of CCCGPA, Karnataka.

Sri Radhakrishna informed the House that most of the founders like Sri N. Bhaskaran, Dr. T S Sathyanarayana Rao and others were not able to attend the meeting due to health issues and prior personal engagements.

The following out going officer bearers were felicitated:

(i) Sri O.M.Bhaskaran who was the Treasurer of CCCGPA for 9 years. He also led Income Tax Employees Federation, Karnataka & Goa and the Income Tax Gazetted Officers Association, Karnataka & Goa. He was the General Secretary of Karnataka Income Tax Department

Pensioners Association.

- (ii) Dr M.R.Hegde, Vice President of CCCGPA, He is also the Secretary of Karnataka Central Government Pensioners Association, Bengaluru
- (iii) Shri Achyuta and Smt.Rama of Omkar Hi Prints who printed the souvenir in a record time of 5 days.

Agenda Item No.2: Confirmation of minutes of the meeting held on 13.08.2022

Sri Radhakrishna informed that minutes of the meeting have already been circulated and placed the same for approval. The minutes were approved by the House.

Agenda Item No.3: Adoption of Secretary's report

Sri Radhakrishna placed the Secretary's report for the year 2022-23 for adoption and the same was unanimously adopted.

Agenda Item No.4: Adoption of Audited accounts for the year 2022-23

Sri O.M.Bhaskaran, Treasurer presented the audited accounts for the year 2022-23. There was a brief discussion on the audited accounts. Sri B.V.Venkatesh, Secretary, KITDPA remarked that the financials of the CCCGPA were too insufficient to manage the day to day affairs of the organization and urged the defaulting affiliates to pay up the arrears of affiliation fee. He also requested the affiliates to pay the annual subscription regularly. To a query by a member on the unit-wise pendency of subscription, Sri Radhakrishna replied that, as on date, 18 associations have cleared the arrears and the remaining 13 have been reminded to clear the dues.

While on this subject, Sri O.M.Bhaskaran informed that Income Tax Employees Federation, Karnataka has volunteered to make a contribution of Rs.10,000 to the CCCGPA. Later, the accounts were adopted by the House.

Sri Radhakrishna placed on record the invaluable services rendered by Dr .M.R. Hegde

and Sri O.M.Bhaskaran to the CCCGPA during their tenure as Vice President and Treasurer respectively. He thanked the members who have made individual contributions / donations on the occasion.

Agenda Items No.5&6 : Health care-CGHS, Non-CGHS and Pensioners of Autonomous & Statutory Bodies and functioning of Local Advisory Committee at CGHS WCs and Zonal Advisory Committee:

S Radhakrishna, G S informed that, after a relentless struggle for almost two decades by the Pensioners Associations, in general, and in particular, by the Karnataka P&T Pensioners Association and Central Government Pensioners Association, Mysuru, CGHS Wellness Centre in Mysuru was opened on 8th September 2022. He also thanked Central Ministers and Members of Parliament who extended their support which helped in finding a solution to the long pending demand of the Central Government employees and pensioners residing in Mysuru and other cities and towns around the City of Mysuru.

He also informed that a Wellness Centre at Hubli is likely to be opened shortly. Hubli-Dharwar Corporation has offered to accommodate the Wellness Centre in its new building under construction and it is understood that, as the building construction is nearing completion, the Wellness Centre is likely to be opened shortly.

The subject relating to opening of more number of CGHS Wellness Centres in Bengaluru City has been taken up by the CCCGPA in the meeting held with the Additional Director, CGHS Bengaluru in order to cater to the health care needs of ever increasing number of beneficiaries. The CCCGPA has also, while emphasising the justification for more WCs, furnished to the AD CGHS the details of the number of Wellness Centres in the neighbouring States and number of beneficiaries in each of those cities vis-à-vis the number of Wellness Centres and the beneficiaries in Bengaluru City.

There has been a vast disparity in the CGHS facilities that are available to the beneficiaries in the cities of neighbouring States and Bengaluru. This issue has also been brought to the notice of the concerned authorities at the CGHS Panchayat Meeting held on 23rd February 2023.

The General Secretary also brought to the notice of the AGB that the CCCGPA under the leadership of its President Sri Krishna Rao along with the other office bearers attended the CGHS Panchayat Meeting held on 23rd February 2023 and raised the major issue relating to revision of CGHS rates, which were fixed in the year 2014, and appealed to the ADDG for revision of CGHS rates at the earliest since many of the CGHS empanelled private hospitals have already sought de-empanelment and many more are likely to go out of CGHS empanelment in the near future.

As a follow-up action, CCCGPA had also requested the Additional Deputy Director General, CGHS HQs, New Delhi, through letters, for immediate revision of CGHS rates as assured by him at CGHS Panchayat meeting and also opening of Additional Wellness Centres at Bengaluru. In view of these repeated requests made by the CCCGPA and other Associations, the Government has issued orders revising the charges for Consultation Fee, the Intensive Care Unit and Room rent reimbursable in respect of the treatment rendered to CGHS beneficiaries. in all HCOs empanelled under CGHS with effect from 12.4.2023. Further the Government has also revised CGHS rates for 36 radiological/ imaging investigations. He also gave details of the CGHS issues and the functioning of the advisory committee of CGHS. Consequent to reconstitution of advisory committees in May 2023, the beneficiaries are required to raise their grievances first at the Wellness Centre level and the unresolved grievances would be escalated to the Zonal Advisory Committee. He explained the technical difficulties faced in empanelment of new hospitals and diagnostic centres. With regard to pending medical reimbursement claims, he informed that bills received up to June 2023 have been settled by the CGHS.

President Krishna Rao explained the procedure for empanelment of private hospitals and appealed to the pensioners to take initiative in empanelling new hospitals by approaching the hospitals if they know the concerned authorities in those hospitals. The CGHS authorities cannot approach the private hospitals requesting them to get empanelled or advertise in the Newspapers calling for applications for empanelment.

Agenda Item No.7: The President updated the House about the position regarding the demand for grant of notional increment to pensioners who had retired on June 30 / December 31.

Agenda Item No.8: Election to the Managment Committee of CCCGPA, Karnataka for the period 23-24 and 24-25

The panel suggested by S Radhakrishna, G S was unanimously approved by the House. The following were elected as office bearers for the period 23-24 and 24-25

Elder abuse awareness

WITH the World Elder Abuse Awareness Day having just gone by, it is necessary to know current views, realities and aspirations of older people and their caregivers.

According to the findings of the National Family Health Survey, which coincided with the release of a report by Help Age India, the over-60 population (whom we call senior citizens and over-80 very senior citizens) has increased from 10 to 12% in the last five years. The report briefly deals with the state of life of the country's elderly (60 + years of age) in terms of gainful employment, volunteering, healthcare, safety and security, inclusion in family and society and the advent of digital boom, particularly access to their usage.

Some of the key findings from the data collected by Help Age India from 200 households in 22 Indian cities, for the elderly and adult caregivers - 16 to 55 years of age living with the elderly - will be of interest to the readers. They are as follows:

FINANCE- 47% of the elderly are financially dependent on family, 34% on pensions, 21% still working and earning, 57% financially insecure owing to their increasing expenses and 45% reported inadequacy of pension.

WORK- 38% refer to lack of employment opportunities, 36% of the elderly are willing to work as long as possible.

HEALTHCARE- 67% of the elderly do not have health insurance. They however feel the need for better health insurance and better health

facilities close at hand. The caregivers also are of the same opinion.

ACCIDENT- 31% of the elderly are in fear of getting hurt in the locality owing to bad infrastructure.

ABUSE - 46% were unaware of abuse redress system. To prevent abuse, the elderly suggested counselling, helpline and awareness campaigns.

SOCIAL INCLUSION - Around 79% of the elderly stated that their families do not spend enough time with them and mentioned lack of social connections.

With the changing lifestyle, our culture of taking care of the elderly in families and society is slowly getting eroded. In the name of civilization people have turned materialistic and in the process the elderly are not getting the attention needed in most families. There are some instances wherein the elderly are sent to old age homes by their children much against their desire. They forget that the elderly, in the evening of their life, need only love and affection from the young. Legal remedy is now available to the elderly if they are harshly treated by their children. However, parents and teachers would do well to train the young in showing respect towards and extending helping hand to, the elderly so that our traditional system of the elderly living with us could remain in existence and thereby the lamp of our culture and ethics could be kept burning.

Life Certificate

Submission of Life Certificate by Pensioners in October/November 2023

All Pensioners are required to submit their Life Certificate to the Pension Disbursing Authority (Bank / Post Office), every year in November before 20th of the month. Pensioners aged 80+ can submit their life certificate either in October or November

Last year 13 members of KP&TPA voluntarily visited residences of 965 aged infirm pensioners to help them to submit their life certificate from the confines of their homes. They organised 23 Digital Life Certificate Camps in Bengaluru and other places Viz: Mysuru, Shivamogga, Hassan and Chikkamagaluru . They helped a record number of **3143** pensioners to submit their digital life certificate making use of the "Face Authentication Technology" launched by the Department of Pension and Pensioners Welfare in collaboration with UIDAI & Ministry of Electronics and Information Technology (Miety).

The Association topped the list of Pensioners Associations in the country in generating life certificates during 2022.

Similarly during this year - 2023, in coordination with Coffee Board Pensioners Association, we will conduct DLC camps and our volunteers will also visit residences of aged pensioners who register their names with us.
